
- New daily cases over 600 as people increased their activities in spring, raising concerns over another wave of the pandemic

- Mandatory wearing of masks in all indoor public spaces is enforced; fine of \$100 will be imposed immediately if caught for not wearing a mask

- Outbound seat capacity for April remains 756 seats
- Lotte JTB will launch overseas travel accommodation coupon promotion in cooperation with Lotte Hotel

PHILIPPINES

- Facing pressure to speed up vaccinations, government confident it could meet its target of vaccinating 70% of the population, saying bulk of its vaccine supply will start arriving in April
- Government ordered an additional five million COVID-19 vaccines from Moderna, in addition to the 20 million they already secured; also expecting 2 million doses from Russia and China
- Government now allows the use of Sinovac's vaccine for senior citizens
- President Duterte relaxed lockdown in the Manila region and four neighboring provinces
- United Airlines and Philippine Airlines announce their flight schedule for April onward

HIGHLIGHT NATIONWIDE

- Number of coronavirus cases in Japan continues to trend upward
- Government decided to designate Osaka, Hyogo, Miyagi, Tokyo, Kyoto and Okinawa for coronavirus pre-emergency response following spikes in infection cases there.
 - Tokyo: until May 11th
 - 5 Prefectures: until May 5th
- Governors will ask bars and restaurants to close by 8 p.m.
- Residents will be urged to refrain from unnecessary travel outside their prefectures
- Prefectural governors asked the government to strengthen screening tests for mutant strains of the coronavirus
- The Ministry of Health plans to starts vaccinations for the elderly on April 12




Haneda Airport:

- The government, in cooperation with the Tokyo Metropolitan Government, began a three-day survey at Haneda airport.
- Period: From April 9 to April 11
- Free distributing over 700 test kits in the arrival lobby

Hokkaido:

- Hokkaido will conduct a trial COVD-19 test at Sapporo Station for targeting visitors from outside of Hokkaido.
- Period : from mid of April to May.
- PCR test kits will be distributed to up to 100 to 200 per day

BORDER CONTROL MEASURES UPDATES

- Travelers from the countries with community transmission of coronavirus variants.
- The government decided on April 9th to add another 4 countries to strengthen border measures for entry.
- Armenia, Cuba, Suriname, and Thailand were added to the list of countries on Apr 9.



Certificate of negative test result taken within 72 hours of departure Entry of Japan is not allowed unless the certificate is submitted (effective from March 19)





Comments from Japan National Institute of Infectious Diseases (NIID):

- Most of the newly infected people in Osaka and Hyogo prefectures are infected with the mutant strain of N501Y (70 to 80%)
- Tokyo metropolitan area will be infected with the mutant strain in early May based on the pace of increase in the Kansai region (about 70% of newly infection)

FACE EXPRESS AT NARITA & HANEDA AIRPORTS

Flow of Personal Information



The airport company obtains boarding pass information from the airline only for those passengers who have completed the procedure on the kiosk screen for participating in the service.



- When the passenger's identification has been successfully authenticated at the boarding gate, the boarding pass information is provided by the airport company for processing by the airline that the passenger is planning to board.
- The passenger is asked to agree to the flow of personal information on the kiosk screen when participating in the service.

OKINAWA NAHA AIRPORT PCR TEST PROJECT

PROJECT SUMMARY:

- Target group: traveler from other prefectures who cannot take the PCR test before traveling to Okinawa and wish to take PCR test
- Location: Naha Airport upon arrival (Meeting room in the domestic terminal building at Naha Airport)
- Laboratory: Okinawa Clinical Laboratory Center, Inc.
- Period: February 3 to September 2021
- Eligibility: Travelers arriving at Naha Airport who wish to take the test. Travelers departing from Naha Airport to other island airports in Okinawa Prefecture. ID like driver license needs to be presented.
- Number of persons inspected: 300 persons/day
- Sample: Saliva specimen collection (specimen collection room) : collect saliva using a sample collection kit
- Application method: Online only
- Testing hours: 9:00 20:00
- Testing fee: ¥ 5,000 yen (¥ 3,000 yen for Okinawa residents) Payment in cash only
- Results: Mail on the same day for morning samples. For afternoon samples, the following afternoon





NEW CORONAVIRUS TESTING CENTERS AT HANEDA AIRPORT

Japan Airport Terminal Co. Ltd and Kinoshita Group opened a new PCR Test Center at Haneda Airport on April 10.

- Rapid antigen test and PCR test will be provided.
- The two centers are limited to travelers on domestic flights only.
- The testing centers will be open from 9am-6pm daily
- The advance bookings are required through online.
- Location:
 - Terminal 1 (Haneda Airport Terminal 1, 4th floor)
 - Terminal 2 (Haneda Airport Terminal 2, B1F)
- Price:
 - Rapid antigen test (collection of nasal wipe) ¥ 1,800 including tax. Result will be notified in about 15 minutes.
 - PCR test (collection of saliva) ¥ 1,900 including tax. Result will be provided in as little as 2 hours.
 - PCR test + Rapid antigen test set : ¥ 3,000 yen including tax.
 - In case of PCR test, the test will not be accepted on the day of departure.
- The coronavirus test will help improve health and safety standards as the number of domestic travelers increases.
- In order to increase the accuracy of the PCR test as much as possible, two types of testing are conducted.
 - 1st test: TOYOBO's kit (SARS-CoV-2 Detection Kit -Multi-)
 - 2nd test: LightMix® Modular SARS-CoV (COVID19) (Roche Diagnostics K.K.)




KOREA COVID-19 NEWS



HIGHLIGHT

- The daily figure hovered over 600 in the past days as people increased their activities in spring, raising concerns over another wave of the pandemic.
- South Korea's daily new coronavirus cases fell back below 600 for the first time in six days Monday partly due to fewer tests over the weekend, amid looming concerns over the fourth wave of the pandemic.

COVID-10 VACCINATION STATUS

Since the country started its vaccination program on Feb. 26, a total of 1,157,255 people have been given COVID-19 vaccine shots. AstraZeneca's vaccine has been given to 916,780 people, while 240,475 received that of Pfizer. 60,511 people have received two doses.

South Korea plans to vaccinate 12 million people by the end of June, with a goal of achieving herd immunity by November.

S. KOREA TO IMPLEMENT FREE COVID-19 TESTS IN ALL HEALTH CENTERS

 Korea will expand the free COVID-19 tests so that anyone can get a free diagnostic test regardless of the social distance level or symptoms at all health centers nationwide.



- The government will strive to prevent the fourth big wave of the pandemic as it can cause a setback in the ongoing vaccination schedules.
- The government will also review the social distance measure that ends this weekend to stem the further spread of COVID-19.

GLOBAL ISSUE UPDATE - GENERAL

THAILAND TO EXPLORE TRAVEL BUBBLE WITH SINGAPORE

- The Thailand Ministry of Tourism and Sports aims to discuss with Singapore a travel bubble between the two countries.
- His ministry aimed to discuss the travel bubble with other ASEAN countries as well, such as Vietnam and Laos where COVID-19 new cases were low.





S. KOREA TO EXTEND CURRENT SOCIAL DISTANCING MEASURES & FACE MASKS MANDATORY IN ALL INDOOR PUBLIC SPACES

- South Korea will retain its current social distancing measures, including the ban on the gatherings of five or more people nationwide.
- The curfew on businesses, such as cafes and karaoke rooms, currently at 10 p.m., however, can be readjusted to 9 p.m. at any time.
- Mandatory wearing of masks in all indoor public spaces is enforced as of April 12 regardless of the social distancing level. A fine of \$100 will be imposed immediately if caught for not wearing a mask.



GLOBAL ISSUE UPDATE - GENERAL



SINGAPORE TO USE IATA'S COVID-19 TRAVEL PASS FROM MAY

- From May 1, passengers traveling to Singapore will be able to use IATA Travel Pass to share their pre-departure Covid-19 PCR test results upon check-in with their airline, as well as on-arrival at the immigration checkpoints at Changi Airport.
- The IATA Travel Pass is a personal secure digital wallet solution that can be used by passengers to obtain and store their COVID-19 test results from accredited laboratories.

UK GLOBAL TRAVEL TASKFORCE SETS OUT FRAMEWORK TO SAFELY REOPEN INTERNATIONAL TRAVEL

- UK Global Travel Taskforce sets out approach to safely restarting international travel which include launch of a **new traffic light system** and 'green watchlist', and the introduction of travel certification, **expecting travel to resume from May 17**, 2021 at the earliest.
- The UK will also play a leading role in the development of international standards around a digital travel certification system.



Countries in each list will be formally reviewed and announced in early week of June 2021.



Arrivals will need to take predeparture test and PCR test on or before Day 2 of their arrival back into the UK - but will not need to quarantine on return (unless they receive a positive result)



Arrivals will need to quarantine for 10 days and take pre-departure test, and PCR test on Day 2 and Day 8 with the option for test to release on Day 5 to end self-isolation early



Arrivals will be subject to restrictions currently in place for 'red list' countries which include a 10-day stay in a managed quarantine hotel, pre-departure testing and PCR testing on Day 2 and Day 8.



TRAVEL TRADE UPDATE

NEW ZEALAND TO OPEN TRAVEL BUBBLE WITH AUSTRALIA ON APRIL 19

- New Zealand and Australia will allow quarantinefree travel between the two countries starting April 19.
- It's the first time since the pandemic required travel restrictions and border closures that conditions have been met allowing for passengers to fly between Australia and New Zealand without needing a 14-day quarantine.



ASIANA TO LAUNCH THEME-TRAVEL FLIGHTS CO-OP WITH DMOS

Asiana Airlines' no-landing flight promotion will make changes by promoting international travel concepts in cooperation with Spain, Australia and Taiwan.

Key Notes

- On the April flight, a performance of a traditional Spanish dance and souvenirs will be provided.
- Korean Spanish Tourism Organization will introduce Spain as well as its cultures on board.



TAIWAN TO EXPAND COVID-19 VACCINATIONS FOR AT-RISK PERSONNEL

Taiwan's COVID-19 vaccination program will be expanded with effect from April 12 to include government epidemic prevention workers and those with a higher risk of COVID-19 exposure due to their jobs, the Central Epidemic Command Center (CECC) said Wednesday.

Taiwan's COVID-19 vaccine rollout began on March 22 and currently, all hospital staff and employees at health clinics, pharmacies and government quarantine centers are eligible to receive the vaccine. This category encompasses an estimated 488,000 people, according to the CECC.

Athletes who are set to compete in the Tokyo Olympics have also begun to receive the vaccine.

FEEDBACKS ON TRAVEL BUBBLE WITH PALAU

CIRCUMSTANCES:

- The first flight with 110 pax has been fully booked, however, many of the seats are reserved by medical personnel groups, media groups, and some travel industry workers. Tourists are only holding a small share of the reservation.
- Many seats are still available for the other 3 flights. Travel agencies are already lowering the tour package price to attract more consumer.

CONCERNS:

Consumer

- 1. Consumers fear of being discriminated by colleagues and family members after returning to Taiwan.
- 2. Although Palau has been reporting O confirmed case, consumers are still concerned about the risk to travel aboard.
- 3. Arriving 5 hours in prior at the airport for testing and 5-day enhanced selfhealth management is another major concern for that consumers' employers might not grant a leave.
- Travel Agencies
 - 1. Flight tickets and tax alone cost NT\$25,000 (about US\$880).
 - 2. The government of Palau has retrieved all the operation right of boats which raised the price of boat tickets.
 - 3. The largest boat could take 25 passengers, and now only 17.
 - 4. The tourism business was suspended due to the pandemic. It takes a lot of fee and human resource to keep the hotels, transportation, and restaurants running.



The original package deal for 4D3N dropped from NT\$75,000 (about US\$2,600), to **NT\$39,900 (about US\$1,137)** with add-ons available, and accommodation at Palau Royal Resort was replaced with Airai Water Paradise.



Short-term business travelers eligible for shortened quarantine periods in Taiwan, except for those who have obtained permission for their application, are now required to complete the 14-day home quarantine.

New Zealand, Macao, Palau, Fiji, Brunei, Laos, Nauru, the Marshall Islands, Bhutan, Australia, Singapore, and Vietnam

VACCINATION ROLLOUT

Facing growing pressure to speed up vaccinations in the Philippines, vaccine czar Carlito Galvez Jr remained confident the government could meet its target of vaccinating 70% of the population, saying the bulk of the country's supply of COVID-19 shots will start arriving in April.

For Galvez and the Duterte government's pandemic task force, a schedule of expected COVID-19 vaccine deliveries is crucial if they are to hold up their promise to achieve herd immunity in the country by the end of 2021.




ANOTHER 5M DOSES OF MODERNA VACCINES ORDERED

The government has order an additional five million doses of COVID-19 vaccines from Moderna. These doses are in addition to the 20 million they already secured under a tripartite agreement with Moderna and the private sector (led by business tycoon Enrique Razon). The government secured 13 million vaccines and the private sector ordered 7 million for its workers.

2M VACCINES DOSES EXPECTED FROM RUSSIA, CHINA

Vaccine czar Carlito Galvez Jr. on Tuesday said the government is expecting 2 million vaccines against COVID-19 this month as the country rushes to inoculate health workers, senior citizens and other priority populations. Galvez said 500,000 doses of Sputnik V from Russia's Gamaleya Institute and 1.5 million doses of CoronaVac from China's Sinovac Biotech are set to arrive this month.



GOVERNMENT ALLOWS USE OF SINOVAC'S VACCINE FOR SENIOR CITIZENS



The Department of Health and the Food and Drug Administration allowed the use of Sinovac's COVID-19 vaccine for senior citizens provided there is stringent evaluation of the person's health status and exposure risk.

PHILIPPINES MARKET INTELLIGENCE





All airline passengers to the United States ages two years and older must provide a negative COVID-19 viral test taken within three calendar days of travel. Alternatively, travelers to the United States may provide documentation from a licensed health care provider of having recovered from COVID-19 in the 90 days preceding travel. Check the U.S. Centers for Disease Control and Prevention (CDC) website for additional information and Frequently Asked Questions.

The Philippine government has suspended the entry of all foreign nationals through April 21, 2021. In addition, there is a daily cap of 1,500 arrivals into Manila's Ninoy Aquino International Airport until 19 Apr. Domestic flights are permitted to reopen from 1 Jun. Non-essential outbound travel is permitted from 21 Oct.



PHILIPPINES EASES MOVEMENT CURBS IN MANILA REGION, SURROUNDS

Philippine President Rodrigo Duterte relaxed a lockdown in the Manila region and four neighboring provinces, as hospitals added capacity for patients infected by the coronavirus.

The national capital region and Bulacan, Rizal, Laguna and Cavite provinces will be placed under so-called modified enhanced community quarantine until the end of April, presidential spokesman Harry Roque said Sunday. Hospitals have added 3,156 beds for Covid-19 patients, he said.

The area - the nation's economic engines - were placed under the most-stringent enhanced community quarantine for two weeks through April 11, as a record surge in infections filled hospitals.



Guam tourism reopening plan announced

By THE MANILA TIMES March 26, 2021

GOVERNOR Lou Leon Guerrero announced the island's tourism reopening plan recently. The plan involves a "path to half" in which Guam aims to fully vaccinate 50 percent of its adult population — approximately 62,500 people — by May 1. Currently, 29,134 individuals on the island are fully immunized. The governor stated that if Guam is able to reach its goal of 50 percent, they will consider changing Guam's quarantine requirement in a first step toward reopening tourism.



Since receiving its first shipment of vaccines on December 15th, 2020, Guam has been proactively vaccinating the island based on their priority groups. As of March 29th,
