WHAT IS GUAM SAFE CERTIFIED?

Guam Safe Certified is the official local designation, which identifies establishments that have the utmost compliance, care, and pride in following government health and safety guidelines.

WHAT IS THE WTTC SAFE TRAVELS STAMP?

The World Travel & Tourism Council (WTTC) created the first ever global safety and hygiene stamp. This stamp enables travelers to recognize destinations around the world that have adopted standardized health and hygiene protocols.

Guam Visitors Bureau (GVB) serves as the official organization to advocate for the implementation of these protocols in Guam and to issue the Guam Safe certification and Safe Travels stamp to local businesses.

Governor Leon Guerrero Signs EO 2021-07



Governor Leon Guerrero Signs Executive Order No. 2021-07

Today, Governor Lou Leon Guerrero signed Executive Order No. 2021-07 relative to extending the public health emergency declaration for an additional thirty (30) day period to May 1, 2021, and orders such that:

- •GUAM CONTINUES TO BE IN PCOR 3, during which most activities are permitted to operate under moderate restrictions imposed in an effort to slow the spread of COVID-19 in our community.
- •EFFECTIVE AT 8:00AM ON THURSDAY, APRIL 1, 2021, indoor dining at eating and drinking establishments shall continue to operate at no more than fifty percent (50%) of the occupancy load, subject to requirements and limitations set forth in applicable DPHSS Guidance, and may now allow up to eight (8) persons to be seated together when dining indoors, with six (6) feet distance between tables. Outdoor dining shall continue to be permitted with no more than fifteen (15) persons per table or per party.
- •EFFECTIVE AT 8:00AM ON THURSDAY, APRIL 1, 2021, Congregations, or "social gatherings" as meetings for common and singular purposes of more than one (1) person where individuals are not members of a single household shall be limited to no more than fifty (50) persons. The terms "social gathering" and "congregation" are not intended to include meetings of businesses, organizations, or government agencies held for the purpose of carrying out official business of such entities.

Individuals and businesses who fail to comply with applicable DPHSS Guidance Memoranda and Directives may be subject to fines pursuant to 10 G.C.A. §19802 and 26 GAR Chapter 4 Article 28, as well as any other penalties available under Guam law. DPHSS and affected agencies may enforce applicable enforcement statutes and regulations with the assistance of the Guam Police Department.

DPHSS Issues Guidance Memo 2021-10 Relative to Operations Under PCOR3

The Department of Public Health and Social Services (DPHSS) issued <u>DPHSS</u> <u>Guidance Memo 2021-10</u>, relative to restrictions and allowances for business and government operations in accordance with Executive Order No. 2021-07 during the current Pandemic Conditions of Readiness 3 (PCOR 3), which was declared by Executive Order No. 2021-04. DPHSS Guidance Memo 2021-10 permits additional authorized businesses and services to operate at up to 75% occupancy load.

Minors may only receive the Pfizer-BioNTech COVID-19 vaccine as the Moderna and Johnson & Johnson/Janssen (J & J/Janssen) vaccines are not recommended for individuals below the age of 18 years. Minors must be accompanied by a parent or legal guardian and provide government-issued identification to validate age.

Upon arrival, individuals 60 years and older will be sent to the front of the line.

PRE-SCREENING ELIGIBILITY FOR VACCINATIONS

In order to take the COVID-19 vaccine, you must meet the following pre-screening eligibility criteria:

- . Must not be currently infected with COVID-19, or previously exposed within the last 14 days
- Must not have received any other vaccine, such as the flu shot, in the last 14 days

COVID-19 News







COVID-19 VACCINATION

JAPAN CABINET ANNOUNCEMENT



- · Aim to strengthen the immune system against infectious diseases.
- Boost the recipient's immune response against infections.
- The vaccine has an effect of reducing the risk of the onset of symptoms such as fever or cough by 95%.



- The Government intends to enable the public to be vaccinated free of charge including foreign residents.
- The municipality where you reside will send you a notice and voucher shortly before it is your turn to receive the vaccination.



- When anaphylaxis or serious symptoms suspected by a doctor to be connected to the vaccination arise, these cases will be reported to the Government and experts will assess the situation.
- The Government is scheduled to conduct a study on health conditions after COVID-19 vaccinations and it will cover around 3 million people in total, including 10 to 20 thousand people.



- Health care professionals and others who provide medical treatment for COVID-19 patients and others directly.
- Persons aged 65 or higher.
- Staff who interact directly with people having underlying conditions or users of elderly care facilities.
- Vaccination for the general public aged 16 or higher will commence afterwards.




- The frequency of anaphylaxis, an acute allergic reaction to components within the vaccine, has been reported to be approximately five cases per million vaccine recipients in US.
- For vaccines administered in Japan, each vaccine recipient is observed for 15 to 30 minute after the injection is given, and should anaphylaxis occur, necessary treatment will be provided by medical professionals.







NEW DOMESTIC TRAVEL INCENTIVE PROGRAM

HIGHLIGHTS

- JTA (Japan Travel Agency) under MLIT has agreed to fund some prefectures to promote domestic tourism.
- The exiting Go To Travel campaign won't resume until June.
- Financial support for discounts for travel within each prefecture.
- The infection conditions the national government has set remains below level 2 or lower.
- ¥7,000 per person per night.
- ¥5,000 for accommodation and ¥2,000 meals or shopping.
- The government reviews which prefectures are applicable for a new program.
- Applicable period : April 1 to May 31, 202
- The planned budget: 300 billion yen.
- The new program will continue until GoToTravel is resumed.

Japan government has agreed to fund some prefectures in subsidizing domestic tourism.



HIGHLIGHT

South Korea's daily new coronavirus cases fell back below 400 on Monday due to fewer tests over the weekend, but health authorities warned of the continued emergence of cluster infections at religious facilities and workplaces.

In South Korea, a third wave of infections, which began in mid-November last year, has shown little signs of slowing down, with the nation reporting daily cases that have hovered around 400 over the past week.

A panel of South Korean advisers said that a COVID-19 vaccine from Johnson & Johnson was safe and effective, the food and drug safety ministry said on Monday (Mar 29), moving the single-dose shot a step closer to receiving regulatory approval.

When granted a green light, the Johnson & Johnson vaccine will be the third COVID-19 vaccine authorised in South Korea, following ones from AstraZeneca and Pfizer-BioNTech, both of which require two doses.

VACCINATION STARTS FOR THOSE AGED 65 AND OLDER AT NURSING HOMES, HOSPITALS

 South Korea began vaccinating people aged 65 and older at nursing homes and long-term care hospitals nationwide on March 23.



- More than 370,000 inpatients in the age group, caretakers and medical staff at such facilities are scheduled to get vaccinated.
- Since South Korea began vaccinations on Feb. 26, around 1.3 percent of the country's 52 million population have received their first shots. The country has secured enough coronavirus vaccines to inoculate 79 million people, higher than its population of 51.6 million, with a goal to achieve herd immunity by November.

CURRENT SOCIAL DISTANCING MEASURES TO BE EXTENDED FOR TWO WEEKS



- South Korea will extend its current social distancing measures for another two weeks amid no clear signs of a letup in new COVID-19 cases (as of March 26, 2021).
- The greater Seoul area will remain under Level 2 distancing and the rest of the country will be subject to Level 1.5.
- Bans on gatherings of five or more people and restrictions on small businesses will also remain in place for another two weeks.



GLOBAL ISSUE UPDATE - GENERAL

JAPAN BANS FOREIGN FANS FROM OLYMPIC DUE TO COVID-19 RISKS



- Japan and the International Olympic Committee have decided that the Tokyo Olympics, scheduled in July, will take place without international fans.
- In Japan, where the vaccine rollout has been relatively slow, the population will not be close to fully vaccinated by the time the Games start.

GERMANY TO GO INTO HARD EASTER LOCKDOWN AS COVID-19 INFECTIONS SOAR



- German announced a hard five-day lockdown over Easter, as the country battles a sharp rise in new coronavirus infections.
- Almost all shops will be closed over the Easter period from April 1 to 5, and no more than five people over the age of 14 from two households can gather.
- The country's general lockdown measures will also be extended until April 18.

DELHI HALTS ASTRAZENECA COVID-19 VACCINE EXPORTS AS INFECTIONS SURGE



- India will focus on the domestic vaccination program following a spike in Covid-19 cases and the planned expansion of the immunization drive, and there will be no expansion of vaccine exports.
- The government's priority will be the vaccination of the country's population and they will review the situation related to exports after about two months.





- MARIANA ISLANDS TO PUT SPURS TO VACCINATION
- Mariana Islands, started vaccination in December 2019, is currently conducting a three-stage vaccination program according to the progress of vaccine supply and has entered the second stage as of March 23, 2021.
- By fall, they plan to secure sufficient amount of vaccines and expand vaccinations to children to complete vaccinations for all residents within this year.

THAILAND TO WAIVE QUARANTINE FOR VACCINATED VISITORS FROM JULY 1

Thailand will waive quarantine requirements for vaccinated visitors arriving on the resort island of Phuket from July 1.

Part of the plan to institute what is being called a "tourism sandbox" involves inoculating at 70%, of Phuket's residents before the July reopening. The inoculations are expected to begin in April.

If all goes smoothly, Thailand expect that around 100,000 tourists can be welcomed in the third quarter of the year.



THAILAND LAUNCHES YACHT QUARANTINE FOR TOURISTS

Thailand's yacht quarantine program will allow visitors with a negative COVID-19 test to spend their time on board in a yacht or small cruise ship in Phuket.

The expanded project endeavors to build confidence in the Thai public health sector and create additional arrival and revenue streams for Phuket tourism operators as the destination gradually reopens to more international visitors.



FOUR NEW SERIOUS ADVERSE EVENTS REPORTED IN VACCINE RECIPIENTS

Thirteen new adverse events, including four serious ones, have been reported among the over 9,200 people who had received their first dose of the AstraZeneca COVID-19 vaccine in Taiwan, as of Friday, according to the Central Epidemic Command Center (CECC).



Taiwan has seen a total of 27 adverse events, including the newly reported 13 cases, since the roll-out of the COVID-19 vaccination began on Monday, CECC official Lo said Saturday.

This was the first time the CECC has reported serious adverse events since a nurse in New Taipei became the first person to experience a severe reaction after receiving the vaccine on Wednesday.

Among the four newly reported serious adverse events, two of the recipients are under observation in hospital because they suffered a fever and shortness of breath, according to Lo.

COVID-19 ANTIBODY DETECTION KIT GRANTED EMERGENCY USE AUTHORIZATION

A rapid COVID-19 antibody detection kit developed by researchers at Chang Gung University (CGU) recently received an emergency use authorization (EUA), paving the way for mass production, the university announced on Thursday.

The test kit, which was jointly developed along with Chang Gung Memorial Hospital, was authorized for use by Taiwan's Food and Drug Administration (FDA) on March 5, the university said in a statement.

According the university, kit the uses samples of blood serum to measure the of potency neutralizing antibodies in a person who has been vaccinated against COVIDand can produce results with 90 percent accuracy in 1.5 hours.

UPDATES ON TRAVEL BUBBLE WITH PALAU

- Palauan President Surangel Whipps Jr Taiwan arrived in afternoon on Sunday (3/28) for a five-day visit to promote tourism to his country, becoming the first head of state to visit the nation since the COVID-19 pandemic began last year.
- The visit also came as a COVID-19 "travel bubble" is to form between Taiwan and Palau, with the first tour group to depart from Taipei on Thursday.



- CDC Deputy Director-General Chuang, the spokesman of the Central Epidemic Command Center (CECC), said the delegation provided negative polymerase chain reaction (PCR) test results from within three days of boarding their flight, so they did not need testing after landing.
- The CECC has also suggested that they wear masks at all times, practice social distancing, record all their close contacts, and avoid contact with local residents, he said, adding that their traffic routes have been planned out in advance and Ministry of Foreign Affairs staff would accompany them throughout the visit.
- They would receive a PCR test before leaving Taiwan, Chuang added.



Short-term business travelers eligible for shortened quarantine periods in Taiwan, except for those who have obtained permission for their application, are now required to complete the 14-day home quarantine.

Individuals with fever or respiratory symptoms such as coughing or running nose are to wear a medical mask, seek medical attention immediately and not to use public transport inform the physician of your contact history, travel history, a whether anyone else has similar symptoms; wear a surgical mask while returning home and avoid going out; and keep 1 meter away from others when talking to them. After being tested for COVID-19 and returning home, individuals are to stay at home and not to go out before receiving results Medical personnel are to halt work and not to come to work temporarily
