THE DEPARTMENT OF REVENUE AND TAXATION ANNOUNCES RELEASE OF ADDITIONAL 93 EIP PROGRAM PAYMENTS; DEADLINE FOR FILING OF FORM EIP-NF IS NOW NOVEMBER 21, 2020

EIP Program Payment Up

The Guam Department of Revenue and Taxation ("DRT") announced today that on Thursday, November 05, 2020, DRT processed 93 EIP Program payments totaling about \$124,566.00. Altogether, for the months of April 2020 through October 2020, DRT processed 82,404 EIP Program payments totaling about \$145 million. This represents about 96.60% of the total funding received from the U.S. Treasury.

In line with the CARES Act, DRT will continue to process EIP Program payments through December 31, 2020. Consistent with the IRS, Guam DRT urges all eligible non-filers to file their Forms EIP-NF as quickly as possible so that they will be able to receive their EIP Program payment.

Deadline for Filing Form EIP-NF

Only eligible, Guam Form EIP-NF filers who file by November 21, 2020, by all filing mechanisms allowed by Guam DRT, will be able to receive their payments by December 31, 2020. Anyone who files after November 21, 2020 will be required to file their 2020 income tax return in order to receive a credit for the Economic Impact Payment.

Deadline for Filing your 2018 or 2019 Individual Income Tax Return for EIP eligibility

DRT must receive your Individual Income Tax Returns by October 15, 2020 to be eligible for the EIP. Based on the EIP Program, a "validly filed and processed" Guam Individual Income Tax Return means that DRT is provided ample time to determine and validate eligibility. Anyone who files their 2018 or 2019 Guam Individual Income Tax Return after October 15, 2020 will not be considered for the advanced EIP. However, these taxpayers may avail of the EIP upon filing of their 2020 Guam Individual Income Tax Return.

EIP Program Notices

Notices were sent to EIP recipients in line with the CARES Act. EIP recipients are encouraged to keep these notices so that when they file their 2020 return, they will be able to reconcile with that notice to claim additional credits should they be entitled.

EIP Program Lookup Portal

For those taxpayers or non-filers who would like to check the status of their EIP Program payment, DRT has launched its EIP CARES Lookup Portal at www.myguamtax.com. Taxpayers/non-filers must register at the Individual Login section of the website in order to check on their payment status. COVID-19 COMMUNITY OUTREACH

The Department of Public Health & Social Services, in collaboration with the Mayors' Council of Guam, FSM Consulate Office, and the FSM Association of Guam, will be holding a COVID-19 Community Outreach this Saturday, November 7, at the Astumbo Gym in Dededo from 9 a.m. to 12 p.m.

DPHSS is providing free COVID-19 testing to the first 200 participants who have registered with the FSM Consulate Office. To pre-register for testing, contact the FSM Consulate Office at 646-9154.

Those who pre-registered for the previously scheduled testing through the FSM Consulate Office will be able to keep their reserved spots. Additional registration for this event is still open.

For the safety of the community and the nurses, only four (4) people per vehicle are allowed to be tested. No symptoms are needed to qualify for testing.

Those who were unable to register for testing through the FSM Consulate Office and are experiencing symptoms consistent with COVID-19 are advised to call their health care provider. A patient may also call the Northern Region Community Health Center (NRCH) at (671) 635-7525/6 to schedule an appointment. The NRCH COVID-19 testing is available by appointment only.




NATIONAL NOVEMBER WRITING MONTH








How to get tested before your trip to Hawaii

Spend less time worrying about your pre-travel COVID-19 test and more time getting excited for your upcoming trip. We're making it simple and easy for you by walking you through the process and providing a list of state-approved testing options to choose from. Learn more about the State of Hawaii pre-travel testing program.

Follow these steps



Select a COVID-19 test option

Choose one of the test options listed below - they are all state-approved and meet the pre-travel testing program requirements. Order a home test kit or make an appointment at a local test location as early as possible.



Take test no more than 72 hours prior to last leg of departure

Specific timing information is provided for each test option. Plan accordingly; without providing a negative test upon arrival, you'll need to quarantine until you receive your results. See the state's travel FAOs.



Create an account on the State of Hawaii "Safe Travels" website

Create your Safe Travels account at least 24 hours before your flight. Fill out the Safe Travels travel and health form and you'll be provided a QR code that will be acanned at the airport when you arrive in Hawaii. Learn more



Upload your negative test result to your "Safe Travels' account

Once you've uploaded a PDF of your test results, your negative pre-travel test result will be verified and your quarantine exemption status will be reflected on your account. Be sure to bring a physical copy of your test results, as you may be asked to show your test results at the airport in Hawaii.

HIGHLIGHT

- South Korea's daily new infections fell back below 100 on November 2.
- Since the country eased its 3-tier social distancing measures by one notch to the lowest level on Oct. 12, the daily figures have shown ups and downs, hovering around 100.
- The latest virus came mostly from senior nursing homes, hospitals and other facilities, but sporadic community infections have been on the rise at small gatherings, including family meetings, across the country.
- Halloween is a major concern for health officials as young people gathered in the popular entertainment areas of Hongdae, Itaewon and Gangnam in Seoul.

NEW FIVE-TIER SOCIAL-DISTANCING REGULATIONS ANNOUNCED

South Korea announced a new five-tier socialdistancing regulations, replacing the existing three-tier scheme in a bid to minimize the closedown of shops and restaurants that hit hard the owners of microbusinesses and ordinary people.

South Korean Prime Minister said that the government redesigned anti-virus measures in a tailored way to enhance effectiveness from the previous regulations under which the uniform closedown was ordered with no consideration of situation in each facility.

Facilities would be simply grouped into "priority" and "regular" ones in terms of the application of anti-virus regulations, noting that wearing mask, which had been mandatory in "high-risk" sites, would be applied to all facilities.

The revised social-distancing scheme came as the government sought to prepare for the prolongation of the COVID-19 pandemic, which requires sustainable anti-virus measures.



TAIWAN CONSIDERS TRAVEL BUBBLES FOR BUSINESS PEOPLE AND DIPLOMATS



The Central Epidemic Command Center (CECC) is considering establishing travel bubbles, but only for travelers who really need to visit Taiwan and are prepared to socially distance, Health and Welfare Minister Chen said Saturday (Oct 31).

While the CECC is expected to toughen up some measures due to the oncoming winter season, business travelers and visitors beneficial to Taiwan's international relations are likely to receive milder treatment.

Visitors will have to show necessity of trip and adhere to effective distancing measures.

JAPAN LOWERS TRAVEL ADVISORY FOR TAIWAN

The Ministry of Foreign Affairs (MOFA) said Japan has lowered its travel advisory for Taiwan, which means Taiwanese nationals will not have to provide a negative COVID-19 report on arrival once Japan opens its doors to tourists.


Under Japan's four-tier warning system, the travel advisory for Taiwan has been downgraded to Level 2, MOFA said in a statement. The announcement was made by the Japanese government at a time when it has yet to fully open to foreign tourists amid the COVID-19 coronavirus pandemic.

Currently, only Taiwanese business travelers, students and people visiting relatives can enter Japan and must go into 14-day guarantine upon arrival, MOFA said.

TAIWAN RESEARCHERS DEVELOP MULTI-FUNCTIONAL COVID-19 RAPID TEST

Researchers at Taiwan's National Chiao Tung University (NCTU) have developed a COVID-19 rapid test that can detect the stage of an individual's infection and produce results in less than five minutes, the university said Tuesday.

The chip-based diagnostic system, which uses blood samples as small as 0.02 milliliters, was unveiled at a press conference by lead researcher and NCTU professor Lin Yi-ping and the project's three corporate partners -- AgriTalk Tech Inc., AllBio Science Inc. and Bio Smart Co.





Compared to standard COVID-19 rapid tests, which simply produce a positive or negative result, the NCTU test determines the stage of the infection based on antibody, antigen and nucleic acid measurements, he said.

According to Chen Wen-liang (陳文亮), a professor at NCTU's Department of Biological Science and Technology, , the test's accuracy, stability and reproducibility are all in the 94-96 percent range and meet international guidelines set by the Clinical and Laboratory Standards Institute.

TAIWAN'S STARLUX AIRLINES TO LAUNCH THREE INTERNATIONAL FLIGHT ROUTES IN DECEMBER

- Despite the challenges the COVID-19 pandemic has unleashed upon the airline industry, Taiwan-based StarLux Airlines Co has announced that it will launch Bangkok, Osaka, and Tokyo flight routes in December, according to a statement from the company.
- Bookings for the Bangkok and Osaka flights will be available from Nov 2, and booking for the Tokyo line will become available mid-November. All can be booked on the Starlux website and at major travel agencies across Taiwan.

EVA AIR PARTIALLY RESUMES PASSENGER FLIGHTS TO BANGKOK

EVA Airways (EVA Air) partially resumed passenger flights to Bangkok, Thailand on Sunday, with China Airlines (CAL) planning to do the same in November as the country begins to lift its travel restrictions.

EVA Air and CAL, Taiwan's two largest carriers, have continued to operate flights between Taoyuan International Airport and Suvarnabhumi Airport in Bangkok during the COVID-19 pandemic, although they have not been entirely passenger flights.

As the Thai government has banned the entry of international tourists since April, flights from Taipei to Bangkok operated by the two carriers have only contained cargo, while passengers in Bangkok can board returning flights to Taipei.



Now that Thailand has begun to ease its travel restrictions, EVA Air plans to resume two round-trip flights per week between Taipei and Bangkok starting Sunday, while CAL plans to operate eight such flights in November and nine such flights in December, the two airlines said Saturday.

The airlines have not set a fixed schedule for the flights as the time and dates will be adjusted depending on the situation of the COVID-19 pandemic, they said.
