Meeting called to order at 4:15 p.m. by Director Mesa.

o Motion made by Director Flores, seconded by Director Kloppenburg, to affirm ratification of approval of travel for a GVB BOD or staff to accompany the Governor to Vietnam to attend meetings with government officials and trade representatives from December 18 – 21, 2010 (Account: 100-5201-CI-SMD023-0, approximately \$6,500.00).

Motion approved unanimously.

Background: The Governor is requesting a GVB representative to accompany him for meetings with Vietnam government tourism officials and trade representatives and officials immediately following MCES in Palau, to discuss regional trade initiatives and opportunities later schedule to take place next week.

Governor Camacho will be meeting with the following Government of Vietnam officials in Hanoi, Vietnam regarding visit and intention for cooperation in Trade, Education, Science and Technology.

Background: Ms. Pilar Laguaña was recently selected Chairperson of the NTA China Inbound Task Force for 2011. This orientation for incoming Chairpersons is for them to get together with the NTA Board of Directors to view the association's goals and to set the foundation for the committees' work to commence early next year. China is a very important strategic market and GVB remains committed in the region and continues work on the China/Russia-Guam Visa Waiver Program. Meanwhile, GVB is positioning to align itself with key industry and travel distribution channels to prime the market for air charters and for eventual direct air service. NTA will reimburse up to \$1,000 for airfare and one day per diem after the trip resulting in \$1,179.00 savings to GVB.

Background: The Philippines Travel Agent Association Travel Tour Expo is the biggest event for the travel and tourism industry. About 80,000 visitors were present in the 2010 edition, which had 461 booths representing 230 firms.

Guam's performers were presented with "Most Popular Performance" award and GVB for its marketing efforts garnered 1st Place – Best Marketing Efforts.

Discussion:

- > GM Perez reported that the cultural performers received the "Most Popular Performance" trophy.
- > P. Laguana stated that the performers did an outstanding job. She stated that they performed five times a day.
- > P. Laguana stated that the booth was converted to a stage and brochure conversational area.
- > P. Laguana stated that there was a lot of inquires with continental selling hundreds of packages.
- ➤ Chairman Mesa stated that the booth next year, there is an opportunity for other GVB members to join and take advantage to participate. He stated that they could follow the JATA model to enhance Guam's booth with supportive members of GVB.
- > P. Laguana stated they launched the new campaign, which is "GOT TO GO TO GUAM." She stated that it is very trendy.
- Motion made by Director Arriola, seconded by Director Kloppenburg, to ratify approval authorizing the General Manager as Chief Procurement Officer of the Bureau to begin negotiations with the highest ranked respondent for RFP: 2011-003 Event Director for Guam Micronesia Island Fair and Guam Ko'ko' Road Race; and, if successful, enter into a contract. Motion approved unanimously.

Background: In accordance with 5GCA Ch.5 Guam Procurement Law, the Bureau issued a Request for Proposal 2011-003 for an Event Director for Guam Micronesia Island Fair and Guam Ko'ko' Road Race. The proposals were evaluated and ranked by the Selection Committee on February 16, 2011.

Issue: Time sensitive and board approval required to proceed with projects.

Discussion:

- > GM Perez stated that the Bureau is already four months behind in the planning process. He stated that there was no problem in the last three years because management had the option to renew the previous contract.
- Director Cristobal inquired if the contract is also for three years.
- > GM Perez stated that the opportunity is for three years subject to satisfaction and approval of the board after each year.
- > GM Perez stated that Japan is waiting for details so that they could sell the packages.
- Director Baldyga inquired what is the contract range.
- > GM Perez replied that the budget is \$150,000 for two events. He stated that the event value is about \$850,000 and the bureau is still paying under \$200,000.
- > GM Perez stated that the game plan is to grow the event value but keep the investment down. He stated that the event manager is responsible for orchestrating it all.
- > Director Arriola stated that the RFP has already gone through the procurement process so the need to do things in a timely manner and if there are any concerns from the board, to do it in the right way.
- o Motion made by Director Kloppenburg, seconded by Director Tayama, to ratify approval authorizing the General Manager as Chief Procurement Officer of the Bureau to begin negotiations with the





highest ranked respondent for RFP: 2011-004 Legal Services; and, if successful, enter into a contract. Motion approved unanimously.

Background: The Agreement with the Guam Visitors Bureau's legal counsel with Lujan, Aguigui & Perez, LLP has expired and is in need of legal counsel representation to provide continuity in its operations, including legal representation, as mandated by its Board of Directors and 12 GCA CH. 9, as part of P.L. 17-32, as amended.

Issue: Time sensitive and board approval required to proceed.

Discussion:

- > GM Perez introduced the new legal counsel, Mr. Tom Fisher and Ms. Georgette Concepcion.
- Mr. Fisher stated that he is happy to be attending the board meeting today.
- > Chairman Mesa stated that GM Perez invited Mr. Fisher to attend the meeting on their own time to introduce them.
- > Director Kloppenburg inquired how the Bureau entered into a contract.
- > GM Perez stated that the negotiation is on an hourly rate, which is close to what was paid to the previous counsel.
- o Motion made by Director Kloppenburg, seconded by Director Cristobal, to ratify approval of travel for 16-member delegation to participate in the inaugural activities for Fly Guam in Hong Kong and Guangzhou from March 4 8, 2011.
