


# Chairman's Report:

- Chairman Baldyga thanked Management and the Board of Directors for their support at the August 6<sup>th</sup>'s Budget hearing at the Legislature.
  - Senator BJ Cruz suggested taking ownership upon TAF funded projects outside of GVB.

- ➤ Chairman Baldyga asked for an update regarding the culvert cleaning projects in which GM Pangelinan responded that the contractor was unable to finish performing due to underestimating the scope of work. They were unable to utilize any of the machinery and were running up against time. There was a request by the contractor to extend the time and money. DPW Director Carl Dominguez was given the budget range and money was taken out of the Rainy Day fund to accelerate the process but was still unable to be completed. He is currently waiting on a call from DPW Director Dominguez.



# Report of the Board Committees:

#### A. EXECUTIVE COMMITTEE

> Election of the new Executive Committee

Director Taimanglo made a motion, seconded by Director Jackson, to nominate Chairman Baldyga, Vice Chairman Kloppenburg and Director Calvo to makeup the new Executive Committee to comply with the new By-Laws.

Motion approved.

Vice Chairman Kloppenburg made a motion, seconded by Director Jackson, to approve Executive Committee's approval of an additional \$10,000 from Sports and Events to sponsor the East Asian Under 18 Football games. (Account ESP001).

Motion approved.

#### Background:

The Guam Football Association requests a total of \$52,500 from GVB in Sports grant funding to execute the East Asian Under 18 Football Tournament here on Guam. The Sports and Events committee has already approved the maximum amount of \$15,000 in Sports Grant Funding. GVB would like to increase its support by providing an additional \$10,000 in sponsorship funding as the event will attract roughly 300 overseas participants including their family members from seven Asian destinations. It is also part of the long term strategy to host larger and more prestigious FIFA sporting events on Guam.

#### Issue:

Board approval required to provide additional funding support.

## Discussion:

- Directors all agreed that it is time for GVB to step up in support of the league being that:
  - o A great job has been done to raise fund, publicity and interest
  - o Placing Guam on the map
  - o It is the best youth development program on the island
  - o The contribution will provide matching funding.



Vice Chairman Kloppenburg made a motion, seconded by Director Jackson, to approve Executive Committee's approval of up to \$14,806 from account FY2012 Carry Over funds for Dr.Michael Levin to travel to Guam from August 10-27, 2013 to convert the current GVB Arrival Forms Processing Integrated Microcomputer Processing System (IMPS) to the Census and Survey Processing System (CSPro) and to conduct two half-day workshops on data edits and tabulations.

## Background:

GVB currently tabulates monthly visitor statistics with the IMPS program. The IMPS program is a DOS-based software and limited in nature to data manipulation. The Census and Survey Processing System (CSPro) is a free software package from the U.S. Census OBureau designed for data entry, editing, tabulation and dissemination of data. CSPro combines the features of **IMPS** and ISSA in Windows environment. Unlike the IMPS software, CS Pro provides a visual approach to the creation and manipulation of data and permits the user to re-structure existing data files and customized subsets of data separate in Dr. Michael Levin received his PhD from the University of Michigan after studying population pressure on scarce resources on Eauripik Atoll in Micronesia. After7yearsat the East-West Center at the University of Hawaii, and almost 30 years at the US Census Bureau, he now works at Harvard University where he assists countries in collecting, processing, and analyzing census data. He has workedonover65censusesoverthelast40years.

### G. RESEARCH:

- Director Taimanglo reported that comparative data of the market share from Okinawa starting from 2010 has been completed and will be sent out to the Board next week.

# H. DESTINATION MANAGEMENT:

- Director Hofmann thanked GM Pangelinan, DGM Denight and Doris for tackling a lot of the action items listed. Director Hofmann added that most of these items will be completed by the end of both fiscal and calendar year.
- > Director Hofmann reported that he is currently working with Legislators and GVB legal counsel about the abandoned building situation.
- DGM Denight reported that we are still waiting upon a price from LMS to include graffiti and vinyl banner removal to the scope of work of the current contract. A law or an MOU with DPW may need to be drafted. DPW is currently trying to get more inspectors on Board to assist in the enforcement.
- Director Guthertz asked for the removal of lions from the old Hong Kong restaurant and placed at the Chinese park. Director Hofmann will look into it with the Chinese Chamber of Commerce.

## RUSSIA & NEW MARKETS DEVELOPMENT

- > Director Jackson reported the next committee will be on August 13 at 10am.
- Director Jackson reported a Russian Charter airline will begin flying directly to Guam late October or early November.
  - o Discussion ensued regarding the Russian charter industry:
    - Not very reputable
    - Criminal element
    - Destinations like Pattaya, Thailand have have expressed that the advent of Russian charter market has had a negative impact
    - Need to continue to monitor Saipan and see how it affects their destination
    - HIS pricing program does not position itself to fit in line with GVB long term goals and objectives. Both GM Pangelinan and Director Jackson have met with HIS to discuss the impact to no avail.



## J. SPORTS & EVENTS

- Director Camacho reported 215 runners have registered for the Koko Road Race's ½ marathon. A GovGuam health and wellness initiative is included to promote more agencies to participate. The Koko Race is being actively promoted in all markets including China. Outrigger has started developing their packages to promote the race. The press conference is scheduled for August 22.
- Director Camacho reported the committee's support of the Jack Nicklaus Golf Academy at Leo Palace. The grand opening will take place on August 15. Sports media from Japan, Korea and China will be here covering it. An instructor, formerly named as Instructor of the Year by a golf magazine will be brought out to do some instruction. The market for this Academy is 4-fold:
  - o Jr. golfers (2-4-8 week program)
  - o Recreational (1 day of instruction / 1 day on the course)
  - o Recreational (2 or more days)
  - o Bring up the teaching capacity and ultimately have locals becoming instructors for the Academy.

The Board will present a Board resolution in support.

> Director Camacho also reported the Baseball clinic with Strike Zone with more details forthcoming.

# K. <u>ADMINISTRATION / GOVERNMENT RELATIONS:</u>

- > Director Guthertz reported on the budget hearing on Tuesday- August 6 and commended Management and staff for a job well done.
- > Chairman Baldyga asked Director Guthertz to work at setting up a meeting with Senator Tina Muna Barnes and aggressively start pushing for the Capital improvements bill.
