IV. CHAIRMAN'S REPORT

- Thanked Management for a successful Air V&V Program
- Businesses and Optional Tours are still closed for business
 - Imperative they open to accommodate visiting tourists from Taiwan
 - Koreans expected in September and Japanese in October-November
 - Management to reach out to Optional Tours and Travel Industry to encourage the opening of businesses
- Reminded GVB staff to reach out to committee chairs in the event of meeting cancelations or postponement
 - 6 Committee Chairs to communicate the information with their community members
- Status of PCR tests protocol JMC & KMC to provide updates

V. MANAGEMENT'S REPORT

President & CEO Gutierrez reported:

- Currently working on getting to airlines and businesses
- Need to instill in the minds of business owners: visitors are here and will continue to visit Guam
 - Military, Taiwanese, Staycationers
 - Activate Trolley operations
 - A good alternative for transportation; rental car companies unable to sustain the level of incoming business
 - Provide more lighting in Tumon
- Incoming Taiwan flights scheduled
- Taiwan's onerous protocol keep customers from taking the opportunity to fly to Guam
 - Possible trip to Taiwan with Chairman Morinaga, Dr. Nguyen, Dr. Cruz, and Chief of Staff to meet with Taiwan Government
 - The purpose is to discuss a reciprocal travel agreement; Guam should not be lumped with the United States



Proposed Rain Shelter

- Corner of JFK (Kmart Intersection)
- Public idea from Ray Gibson
- Beneficial to tourists and students from JFK
- Director Ferguson requested more lighting at the intersection; dark in the evening
- Director Dela Cruz requested the intersection have a mechanism for the hearing and sightimpaired

Vice President Perez reported:

Air V&V

- The team discussed ideas to bring visitors back to Guam
- President Gutierrez came up with the concept of Air V&V (GVB patented)
 - Green shoots of opportunity to get Guam back on track
 - Stimulates our industry that has been on lockdown for a year and a half
- 917 arrivals to date, with another 170 scheduled to arrive at 2:55 PM today
- Vaccine
 - Pfizer: 558
 - People's choice
 - Pfizer can provide a cocktail with AstraZeneca when they return to Taiwan, enabling them to take their second shot in their homeland
 - Moderna: 147
 - Johnson & Johnson: 149
- Following charters from Taiwan: 7/27, 8/2, 8/8, and 8/12 (est. 800 pax)
- Taiwan continues to send charters to Guam organized by Phoenix Tours, and Lion Travel drove the market with GVB
 - Actively selling Guam and gaining traction
 - The amount of earned media coverage is more than GVB's budget on an annual basis
 - According to President Gutierrez, Angel is an actress with over 2M followers with 5 TV Network stations
 - She stayed at Nikko Hotel Guam, where she received her first shot and documented the process, and shared it with followers
- Four airbus 321-300 flights arrived starting on July 6
- July 22 Airbus 333-300 with 299 passengers

- The total air seat capacity forecast for FY21 is 142,333 seats

South Korea

- All flights from Korea to Guam are suspended, except for Jin Air & T'way (outbound seat capacity for July is 945 seats)
 - Jin Air weekly flight scheduled July 6, 13, 20, 27
- South Korea extended its special advisory against overseas travel until August 14
- T'way and Korean Air are resuming regular one-time, weekly service; T'way on July 31 and Korean Air on August 6.
