What is the annual membership fee?

- ➤ One Hundred Dollars (\$100) for the fiscal year period of October 1 to September 30. \$100 entitles each member to one vote, up to a maximum of 10 votes.
- ➤ Membership fees are not pro-rated.
- Registration by the second Friday in October guarantees listing in the GVB Membership Directory.

What is the composition of the GVB Board of Directors?

Twelve (12) members comprised of:

- ➤ Four (4) elected by the membership to serve a term of 2 years;
- ➤ Five (5) appointed by the Governor to serve at the pleasure of the Governor for a term of two years;
- ➤ Two (2) appointed by the Speaker of the Guam Legislature to serve a term of two years; and
- ➤ One (1) elected by the Board to serve a term of two years.



Who is eligible to vote?

A contributing member whose annual membership fee is paid within ninety (90) calendar days prior to a membership election in which such member intends to vote. Elections are held every other year in January.
