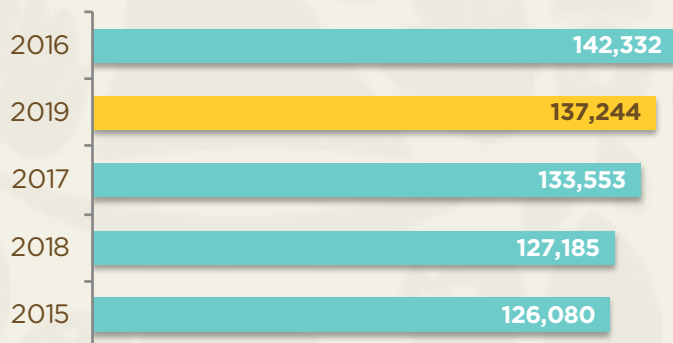

Typhoon Wutip caused **25** flight cancellations which resulted in **4,993** seats lost for February 2019.

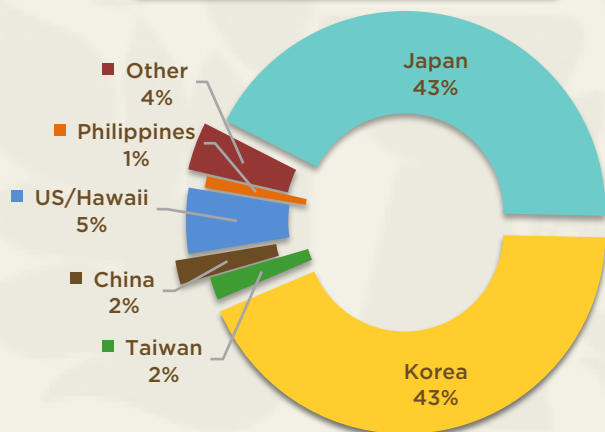

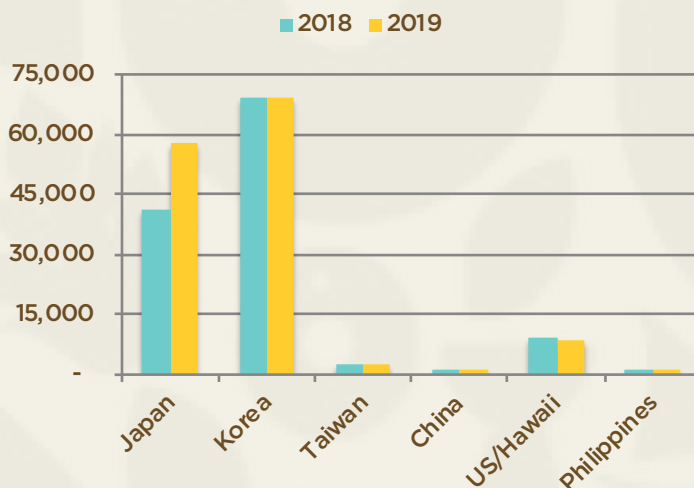

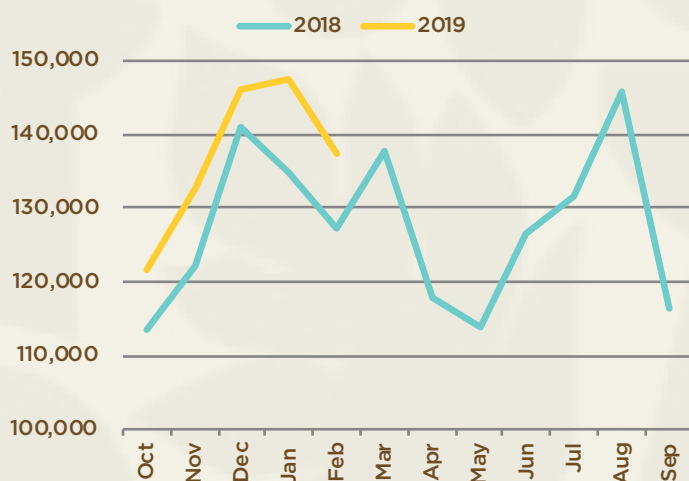
