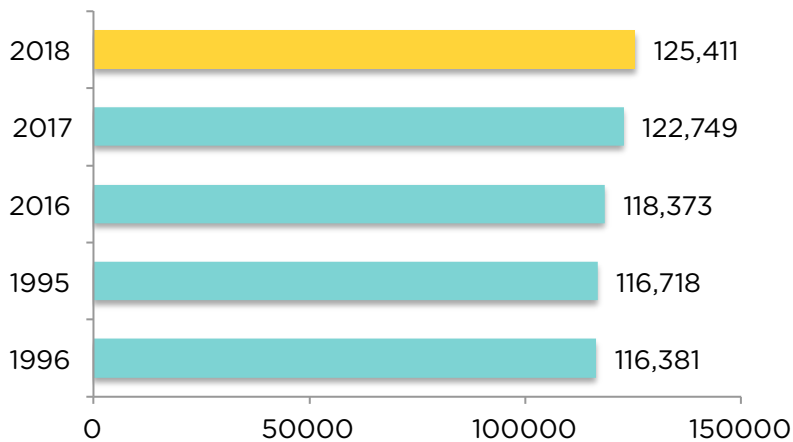

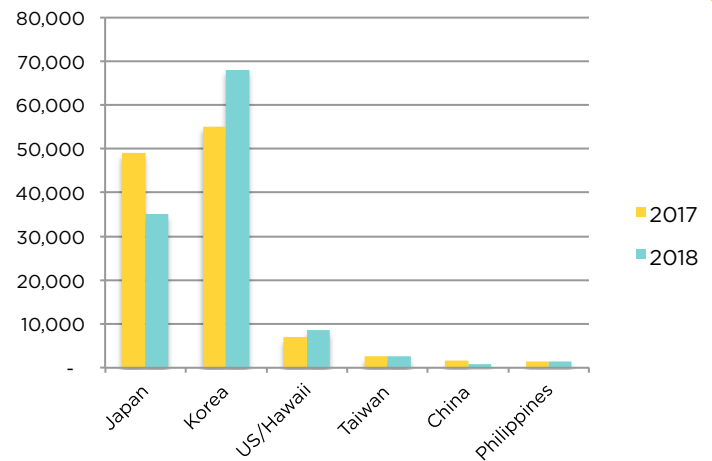

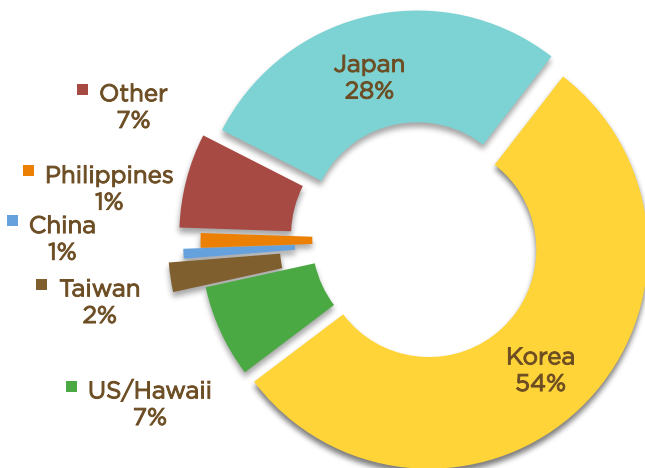
Top 5 June Arrivals
