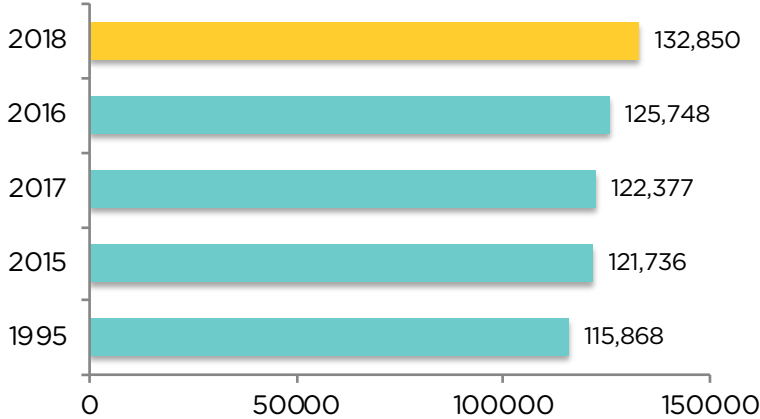

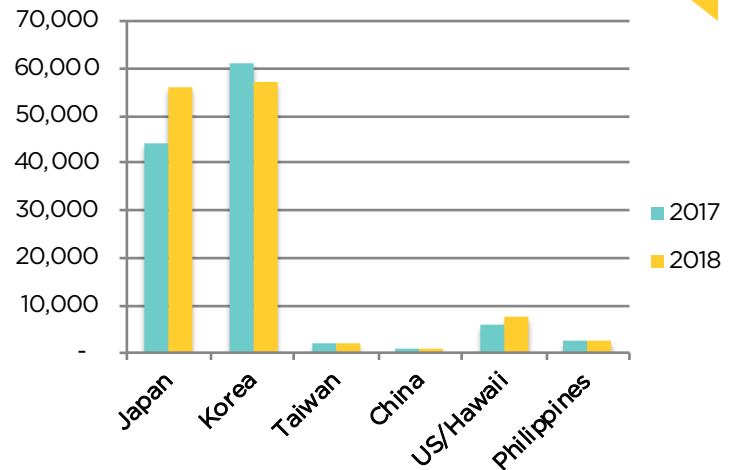

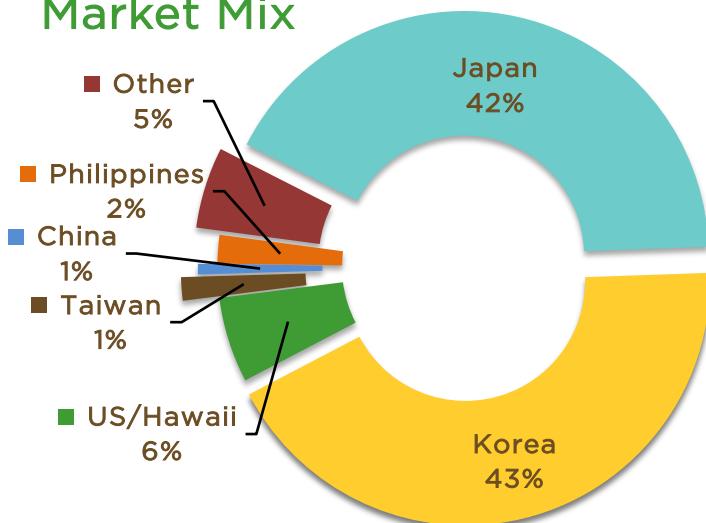
Top 5 November Arrivals
