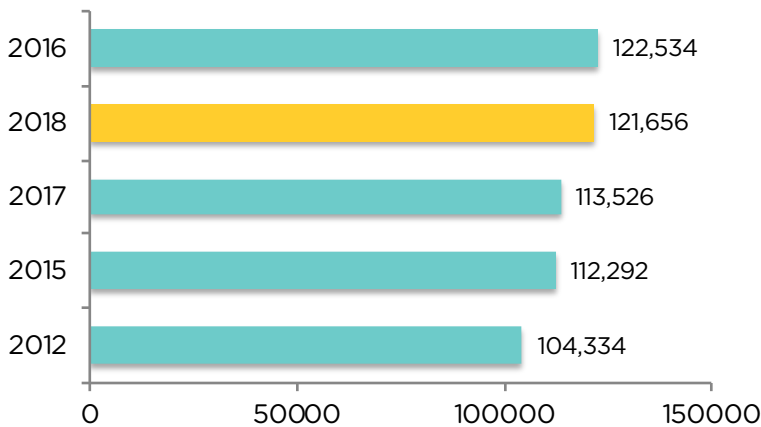

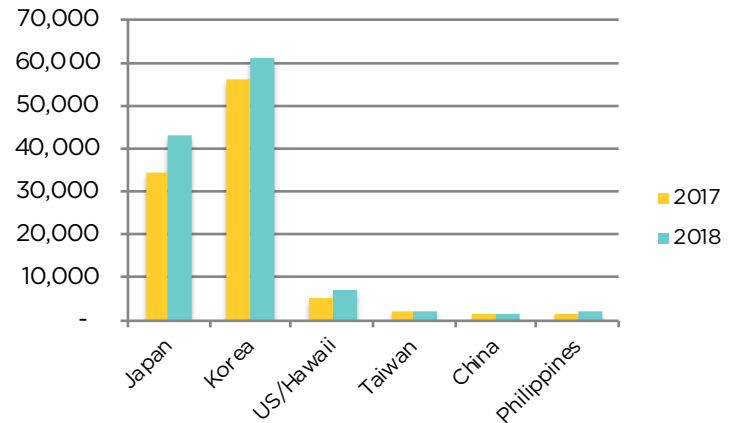

The overall on-island spending for visitors in FY2018 grew by **2.6%** over last year.

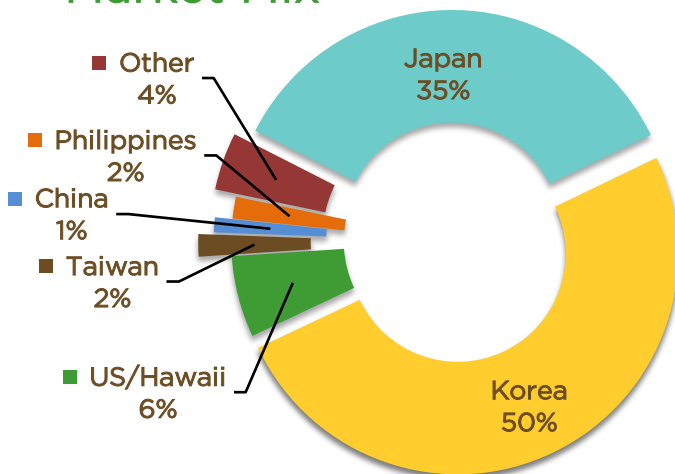
## Top 5 October Arrivals
