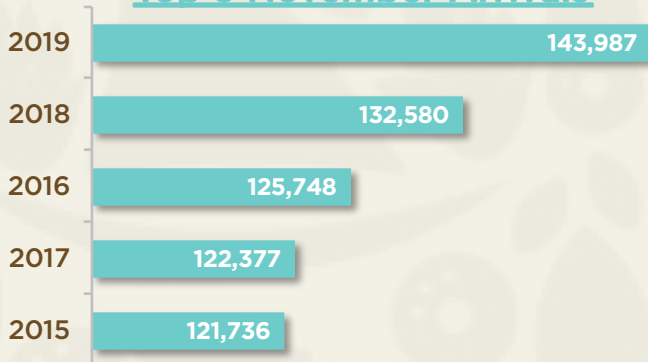
DID YOU KNOW?

Guam's visitor arrivals dropped **-95.8%** from March to November 2020 as a direct result of COVID-19 pandemic.

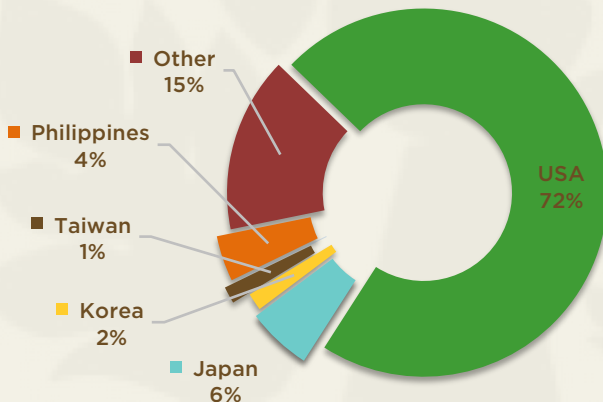

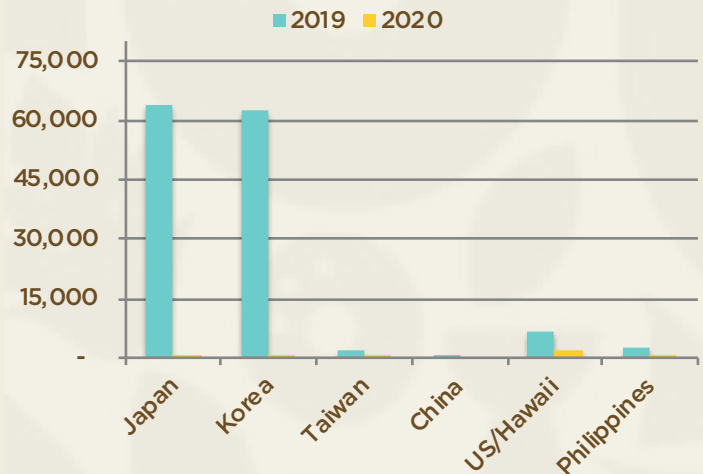

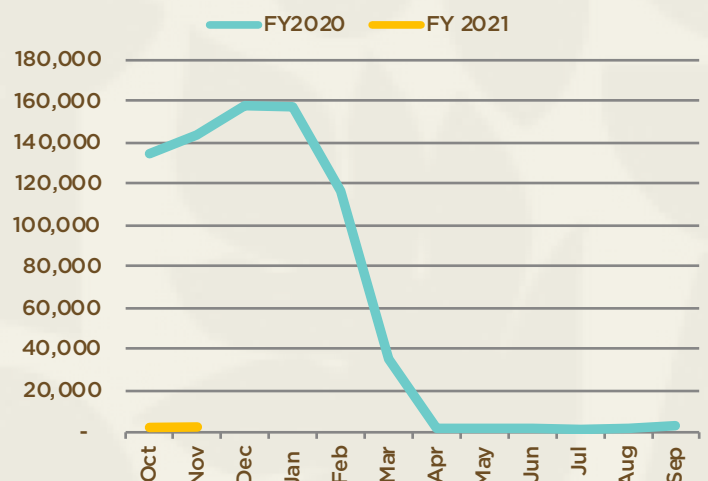
