**EXECUTIVE ORDER NO. 2020-15**

**RELATIVE TO THE EXTENSION OF *PRUGRĀMAN SALĀPPE' AYUDON I TAOTAO*, A DISASTER RELIEF PROGRAM**

**WHEREAS**, on May 5, 2020, I, Lourdes A. Leon Guerrero, *I Maga'hågan Guåhan*, Governor of Guam, acting pursuant to the power provided to me by the Organic Act and the laws of Guam, issued Executive Order 2020-12 and created *Prugråman Salåppe' Ayudon I Taotao*, a disaster relief program; and

**WHEREAS**, the program has been highly successful in not only providing Guam households with much needed access to cash assistance, but also access to other public health assistance programs; and

**WHEREAS**, the Mayors' Council of Guam ("MCOG") has been instrumental in assisting households apply for this program; and

**WHEREAS**, the MCOG has communicated that more households are in the process of applying and need additional time; and

**WHEREAS**, the budget allocation for this program allows for its extension.

**NOW, THEREFORE, I, LOURDES A. LEON GUERRERO**, *I Maga'hågan Guåhan*, Governor of Guam, by virtue of the authority vested in me by the Organic Act of Guam, as amended, do hereby order:

1. **Extension of *Prugråman Salåppe' Ayudon I Taotao* ("The Program")**. The Program is hereby extended to allow applications through June 12, 2020. All other provisions of Executive Order 2020-12 shall remain in full force and effect.
