### EXECUTIVE ORDER NO. 2020-37

### RELATIVE TO AMENDING EXECUTIVE ORDER NO. 2020-23 CREATING THE OFFICE OF HOMELESSNESS ASSISTANCE AND POVERTY PREVENTION

WHEREAS, on June 30, 2020, I issued Executive Order No. 2020-23, reconstituting the Interagency Council for Coordinating Homelessness Programs ("Interagency Council") and establishing the Office of Homelessness Assistance and Poverty Prevention ("OHAPP"); and

WHEREAS, since issuing Executive Order No. 2020-23, Lt. Governor Joshua Tenorio, in his capacity as Chair of the Interagency Council, has led significant efforts to address homelessness concerns in our community, especially in light of the particular challenges presented by the COVID-19 public health emergency; and

WHEREAS, while the Mayors' Council of Guam remains uniquely positioned to identify issues facing our island's homeless population, it does not currently have the capacity or the resources to administer OHAPP's critical programs.

NOW THEREFORE, I, LOURDES A. LEON GUERRERO, I Maga'hågan Guåhan, Governor of Guam, by virtue of the authority vested in me by the Organic Act of Guam as amended, do hereby order:

1. Section 2 of Executive Order No. 2020-23 is hereby amended to read:

OFFICE OF HOMELESSNESS ASSISTANCE AND POVERTY PREVENTION. There is hereby created the Office of Homelessness Assistance and Poverty Prevention in the executive branch and under the administrative supervision of the Office of the Governor, in close coordination with the Mayors' Council of Guam.

2. All other provisions of Executive Order No. 2020-23 shall remain in full force and effect.
