One Tests Positive for COVID-19 by DPHSS, One Probable Case Confirmed by GRMC

The Department of Public Health and Social Services (DPHSS) tested 64 individuals for COVID-19 on Wednesday, May 27, 2020 with conclusive results. One tested positive through DPHSS and 63 tested negative for SARS-CoV-2.

One new probable case of COVID-19 was reported earlier today to DPHSS from the Guam Regional Medical City (GRMC).

To date, there have been **171** cases confirmed through COVID-19 testing provided with **5** deaths, **143** released from isolation, and **23** active cases. New criteria for release of cases from isolation were implemented on May 22. For persons *having symptoms*, at least 10 days have passed since recovery defined as resolution of fever without the use of fever-reducing medications and improvement in respiratory symptoms (e.g., cough, shortness of breath) and any other symptoms attributed to COVID-19 infection AND at least 10 days have passed since symptoms first appeared—or, with recurrent symptoms, at least 10 days have passed since recurrent symptoms appeared—AND at least 14 days have passed since the date of their first (or most recent) positive COVID-19 diagnostic test. For persons *without symptoms*, at least 14 days have passed since the date of their first (or most recent) positive COVID-19 diagnostic test assuming they have not subsequently developed symptoms since their positive test.
