## One Confirmed Case from DoD; Profiles of Earlier Confirmed Cases; Expanded COVID-19 Testing Continues

One new case of COVID-19 was reported today by the Department of Defense (DoD) and was identified through contact tracing.

COVID-19 test results are reported from multiple labs at varying times of the day. Cumulative test results will be provided this evening once all tests from today are finalized.

To date, there have been **186** cases confirmed through COVID-19 testing provided with **5** deaths, **169** released from isolation, and **12** active cases. As this is an evolving situation, information is subject to change with little to no notice. - Wednesday, June 24, 2020, 9 a.m. 12 p.m. at the Agana Heights Mayor's Office
  - o Free and open to Hagåtña and Agana Heights residents
