A total of 15 cases of COVID-19 were confirmed today. Of the fifteen cases, four cases were identified through contact tracing. Two cases reported recent travel from the continental US and were identified in a quarantine facility.

To date, there have been a total of **449** confirmed cases of COVID-19 with **5** deaths, **341** released from isolation, and **103** active cases. Of those cases, **398 are classified as civilians** and **51 are military service members**.
