The Guam Customs and Quarantine Agency is responsible for protecting Guam against the illegal importation of prohibited items. Customs Officers have the authority to question and examine you and your personal property. If selected for examination, you will be treated in a courteous, professional, and dignified manner. The Customs Officer Supervisor or Officer-In-Charge on duty is available to answer your questions.

WARNING: The importation of controlled substances into Guam is a felony of the first degree (Title 9 GCA, Section 67). Violation of this section carries a mandatory prison sentence of up to ten (10) years. False statements made to a Customs Officer are punishable by law. All of your baggage, handbags, and hand-carried articles may be opened and examined. If you have any questions about what must be reported or declared, ask a Customs Officer. To prevent the entry of dangerous agricultural pests or prohibited wildlife, the following are restricted: fruits, vegetables, plants, plant products, soil, meat, meat products, birds, snails and other live animals or animal products. Failure to declare such items to a Customs Officer can result in fines and the items may be subject to seizure. The Internal Revenue Laws of Guam require that you declare ALL goods, articles, or merchandise acquired abroad, whether worn or used, taxable or not, and whether obtained by purchase, as a gift or otherwise.
