TAIWAN CHARTER

On July 6, the Guam Visitors Bureau and A.B. Won Pat International Airport Authority welcomed Guam's first direct flight from Taiwan in more than a year and a half. The EVA Air charter flight carried 153 passengers to the island to participate in Guam's vaccination tourism program — Air V&V. The charter was coordinated by Taiwan travel agencies Lion Travel and Phoenix Tours. Additional charters are being planned with more than 2,000 visitors from Taiwan expected in July and August.



PUBLIC HEALTH DESERVES OUR SUPPORT

Håfa adai! Gov. Lou Leon Guerrero's executive order lifting the COVID quarantine for travelers who show negative PCR tests within 72 hours of arrival in Guam is a welcome relief.

Our visitor industry is in desperate need of resuscitation before the island's \$2.5 billion in federal pandemic subsidies run dry by year's end.

But this relaxation of isolation protocols is also a double-edged sword that must be carefully handled if our tour and travel trade is to recover as safely and efficiently as possible.

Truly, no one is expecting 130,000 monthly passengers to come rushing through airport gates again any time soon. But the recent crush of disembarking passengers held up by stacks of paper health-screening forms is a poignant reminder that even our best-laid plans are vulnerable to unforeseen circumstances.

In addition to GVB President & CEO, former Governor Carl T.C. Gutierrez is the permit czar and chairman of the Governor's Economic Strategy Council.

MARKETS AT-A-GLANCE



JAPAN

- If infections continue to spread, the government may extend the COVID-19 pre-emergency designation beyond June 11.
- The government is targeting November to vaccinate all willing people.
- State-run mass vaccination centers in Tokyo and Osaka may close in August.
- People are feared dead and some are missing after mud slides and heavy rains brought on by a seasonal front affected Tokai central, Kanto eastern and Kinki western regions on July 2.
- In line with the government's goal, 30 million doses of the vaccine have been administered to the 65 and above population.
- The government will begin issuing vaccination certificates (vaccine passports) during the latter part of July in order to resume international human traffic.
- The opening and closing ceremonies for the Olympic Games might not be open to spectators.
- The state of pre-emergency is enforced in 10 prefectures.
- Okinawa is still under the state of emergency until July 11.
- Week-on-week increases have been continued for 14 days straight.
- The government has secured 100 million doses of Pfizer by June and 70 million doses are expected between July and September.

- Projected dates for flights and package sales

TAIWAN

- CECC pushes for markets to comply with disease controls in light of the recent increase in foot traffic.
- Taipei City health officials have been reassigned over a scandal involving clinics administering COVID-19 vaccines to people not eligible to receive them.
- Taiwan is currently under a Level 3 COVID-19 alert, which extends at least through July 12. There is talk of "partial reopening," even if the alert is extended.
- A major travel agency in Taiwan reported that it has been selling hundreds of tours to Guam, as people are taking advantage of the American territory's offer to vaccinate tourists against COVID-19.
- Starting June 27, travelers arriving in Taiwan from countries other than the seven countries at high risk of COVID-19 variants, including those who have visited the countries in the past 14 days and those who have transited in the countries, will be allowed to stay in group quarantine facilities at their own expense

SOUTH KOREA

- Beginning on June, South Korea's daily new cases remained in the 700s for six consecutive days.
- 5,321,602 people have been fully immunized.
- Due to the rise in cases, the introduction of the new social distancing measures have been postponed by one week in the entire Seoul capital region
- People who have been vaccinated overseas will be exempt from the mandatory two-week quarantine upon arrival in South Korea.
- On July 1, the Korea-Saipan Travel Bubble was established.
- Korean Air may resume Guam route in early August.
- Seat capacity for the month of July: 945.
- Incheon Airport will "Trip Booster" to provide monetary support to airlines and travel agencies operating "safe travel products".

PHILIPPINES

- Those fully vaccinated in the Philippines are now exempt from the RT-PCR test requirements upon arrival in the Philippines and will only undergo a 7-day quarantine at an accredited quarantine hotel or facility. Filipino Nationals and non-Filipinos who received their vaccination outside the Philippines are NOT eligible for the exemption and reduced mandatory quarantine.
- The government established a list of "green" countries allowing travelers originating from these countries to quarantine for a shortened period.
- On July 8, the Philippines received 1 million doses of the AstraZeneca vaccine donated by Japan.
- The Philippines is set to receive another 2 million AstraZeneca doses from vaccine-sharing COVAX Facility this week, and about 170,000 government-procured doses from Russia's Gamaleya Institute.



GUAM ENTRY PROTOCOLS

Executive Order No. 2021-10

QUARANTINE FOR INCOMING TRAVELERS. Pursuant to applicable law and the Department of Public Health and Social Services (DPHSS) Guidance, all incoming travelers shall be subject to quarantine at a government facility.

- CDC GUIDELINES FOR INTERNATIONAL TRAVEL. On January 12, 2021, the CDC announced an Order requiring all air passengers arriving in the U.S. from a foreign country to get tested no more than three (3) days before their flight departs and to present the negative result or documentation of having recovered from COVID-19 to the airline before boarding the flight. Air passengers will also be required to confirm that the information they present is true in the form of an attestation.
- EXEMPTION FOR VACCINATED TRAVELERS. Effective at 12:01AM on May 15, 2021, all incoming travelers who have been fully vaccinated with an FDA approved COVID-19 vaccine authorized for emergency use (i.e. Pfizer-BioNTech, Moderna, or Johnson & Johnson/Janssen), upon verification, are not subject to quarantine at a government facility. Travelers availing of this exemption shall be required to self-monitor for COVID-19 symptoms and comply with applicable DPHSS Guidance, including for verification requirements.

Executive Order No. 2021-13

QUARANTINE FOR INCOMING TRAVELERS. Pursuant to applicable law and the Department of Public Health and Social Services Guidance (DPHSS), all incoming travelers shall be subject to quarantine at a government facility.

- EXEMPTION FOR VACCINATED TRAVELERS EXTENDED TO INDIVIDUALS WITH WORLD HEALTH ORGANIZATION (WHO) AUTHORIZED VACCINES. Effective at 12:01AM on June 19, 2021, all incoming travelers who have been fully vaccinated with an FDA or WHO authorized COVID-19 vaccine (including, but not limited to, Pfizer-BioNTech, Moderna, Johnson & Johnson/Janssen, and AstraZeneca), upon verification, are exempt from quarantine. Travelers availing of this exemption shall be required to self monitor for COVID-19 symptoms and comply with applicable DPHSS Guidance, including for verification requirements.
- UNVACCINATED TRAVELERS. Effective at 12:01AM on June 19, 2021, incoming travelers who, upon 72 hours of arrival in Guam, present a negative PCR or antigen test taken within 72 hours of arrival, are eligible for home quarantine and self-monitoring as provided in applicable to DPHSS Guidance.

Executive Order No. 2021-15

PRE-ARRIVAL NEGATIVE COVID-19 RT-PCR TEST

- Passengers who present a negative COVID-19 RT-PCR test may be exempt from quarantine. Passengers seeking exemption from quarantine under this section must present the following at the port of entry upon arrival:
 - Photo identification (e.g., passport, driver's license, state-issued identification);
 - Valid negative COVID-19 RT-PCR test result collected within 72 hours prior to arrival into Guam.

Travelers who do not meet the quarantine exemption criteria above will be subject to quarantine in a government facility.

JAPAN ENTRY MEASURES



- **Secure negative certificate 72 hours prior to departure; airline to verify; test again upon arrival**
Approved tests:
 1. Real time RT-PCR: real time reverse transcription PCR
 2. LAMP: Loop-mediated Isothermal Amplification
 3. TMA: Transcription Mediated Amplification
 4. TRC: Transcription Reverse-transcription Concerted reaction
 5. Smart Amp: Smart Amplification process
 6. NEAR: Nicking Enzyme Amplification Reaction
- **Smartphone requirements***
 1. OEL (location reporting app)
 2. Report health condition daily via website (URL provided to traveler via email)
 3. MySOS (confirm location by video call from Health Monitoring Center for Overseas Entrants)
 4. COCOA (COVID-19 contact app)
 5. Google Maps (location data when positive)
 - *Traveler will be required to rent a smartphone if they do not own one*
- For Japanese nationals who have negative result in both tests, leave the facility and are requested to self-quarantine at home during the remaining period of 14 days after entering Japan



- Requires a negative PCR test 72 hours prior to departure
- Fill out electronic health declaration form prior to departure via Quarantine System for Entry @ <https://hdhq.mohw.gov.tw>
- Travelers are required to make an affidavit stating that the location of their intended **14-day quarantine** in Taiwan meets relevant regulations
- All travelers will be quarantined for 14 days with the following exceptions:
 - Short-term business with advance permission for shortened quarantine period

SOUTH KOREA ENTRY MEASURES

TRAVELERS TO KOREA

- All travelers to Korea must provide proof of a negative PCR test result collected within 72 hours of their departure
- As of May 5 - those fully vaccinated in South Korea can bypass quarantine; PCR test required on day 6/7
- Those not fully vaccinated in Korea must undergo 14-day home quarantine; PCR tests required on day 1 and day 12/13
- Korean nationals arriving without a negative PCR test will be required to undergo a 7-day quarantine at a government facility at their expense, followed by 7 days of home quarantine
- Foreigners arriving without a negative PCR test will be denied entry



PHILIPPINES ENTRY MEASURES

WHO IS ALLOWED TO ENTER?

- Filipino nationals
- Non-Filipino/Foreign spouse and minor children or children with special needs of a Filipino national
- Non-Filipino/Foreign parent of a minor Filipino child (18 years old and below) or a child with special needs (regardless of age)
- Former Filipinos (Balikbayan Program), Dual Citizens
- Spouse/Children of Former Filipino Nationals (Balikbayan Program)
- Accredited foreign government and international organization officials and their dependents
- Non-Filipino/Foreign seafarers with 9(c) visa
- Non-Filipino/Foreign nationals in possession of valid certificates
- Non-Filipino/Foreign nationals with an eligible visa

REQUIREMENTS

Eligible arrivals to the Philippines must take a COVID-19 RT-PCR test upon arrival followed by a 14-day quarantine. Arrivals will be tested on the seventh (7th) day of their 14-day quarantine stay, 10 of which shall be observed at an accredited quarantine hotel/facility, and the remaining days for home quarantine under the supervision of the Local Government Unit of their residence. Day one (1) starts on the day of the passenger's arrival.



ADVISORY

REVISED GUIDELINES AS PER IATF-MEID RESOLUTION NO. 113 SERIES OF 2021

In view of the foregoing, the following guidelines shall govern the entry of passengers to the Philippines **beginning 01 May 2021**:

I. ALLOWED TO TRAVEL TO THE PHILIPPINES

1. Filipino citizens, including those with Identification Certificate (IC) as proof of recognition as a Filipino citizen or as proof of retention/reacquisition of Philippine citizenship under RA9225;
2. Foreign nationals with valid and existing visas at the time of entry;
3. Foreign nationals allowed entry under the Balikbayan Program (RA6768), provided they are nationals from non-visa required countries under EO408:
 - a. Former Filipino citizens, together with their foreign spouses and children, regardless of age, who are travelling with them; and
 - b. Filipino citizens' spouses and children, regardless of age, who are travelling with them.
4. Foreign nationals who are holders of valid and existing Special Resident and Retirees Visa (SRRV) or Section 9(a) visas, provided they present, upon arrival, an entry exemption document issued by the Department of Foreign Affairs.

Except for Section 9(e) visa holders who are covered by a different testing and quarantine protocols, the entry of all other foreign nationals shall be subject to the following conditions:

- a. With pre-booked accommodation for at least seven (7) nights in an accredited quarantine hotel/facility; and
- b. Subject to COVID-19 testing at the quarantine hotel/ facility on the sixth (6th) day from date of arrival.

The pre-booked accommodation for at least seven (7) nights in a quarantine hotel accredited by the Department of Tourism (DOT) shall be presented for initial check at the immigration counters. Those who fail to present a pre-booked accommodation shall be denied entry and shall be boarded immediately in the next available flight.

Foreign nationals who were cleared for entry but subsequently found to have presented a counterfeit or fraudulent pre-booked accommodation upon validation by the DOT, or those who will violate the testing and quarantine protocols of the Department of Health, shall be subject to deportation.

At least of one of the following three documents will be accepted for vaccination verification upon arrival: Philippine-issued vaccination record, Philippine overseas labor office (POLO) certificate, or WHO's international certificate vaccination

JAPAN MARKET SUMMARY

HIGHLIGHTS



- The Japanese government is seen extending the novel coronavirus pre-emergency designation for the greater Tokyo area beyond the July 11 expiration if infections continue to spread.
- The government sticks to its goal of vaccinating all willing people by November.
- The Japanese government is planning to end the full-fledged operation of state-run mass vaccination centers in Tokyo and Osaka in late August as planned.
- The Defense Ministry announced on June 28 the Tokyo center has offered 328,736 shots, while the Osaka center has given 161,341 shots.

- A seasonal front over the Pacific side of Japan brought heavy rain to areas in the Tokai central, Kanto eastern and Kinki western regions on July 2. Two people are feared dead and about 20 others remain missing after torrential rain triggered a large mudslide southwest of Tokyo, destroying more than 10 houses.
- Japan has administered over 30 million doses of COVID-19 vaccine to people aged 65 or over, on track to achieve the government's goal of completing inoculations for them by the end of July.
- The Government of Japan has decided to begin issuing vaccination certificates (vaccine passports) from the middle to end of July in order to resume international human traffic.



- The number of people in Japan who have received the first dose of the coronavirus vaccine surpassed 30 million (24%) as of July 2, and the total number of people who have completed the second dose is about 16 million (13%).
- There is a possibility that the opening and closing ceremonies of the Tokyo Olympics will be without spectators.
- The Olympic Organizing Committee will hold a five-body meeting with the government and the International Olympic Committee (IOC) on July 8 or 9 to decide the maximum number of spectators.


JAPAN COVID-19 NEWS

HIGHLIGHT

- The state of pre-emergency is enforced in the following 10 prefectures: Hokkaido, Tokyo, Saitama, Chiba, Kanagawa, Osaka, Kyoto, Hyogo, Aichi and Fukuoka.
- Okinawa is still under the state of emergency until July 11.
- Japan is considering extending its coronavirus pre-emergency in Tokyo and three neighboring prefectures of Kanagawa, Saitama and Chiba.
- Medical experts pointed out the increased ratio of the number of new positive cases in Tokyo has risen, suggesting the infection is spreading again.
- Week-on-week increases have continued for 14 consecutive days.
- Possible causes for the resurgence of the infection:
 - State of emergency to pre-emergency measures.
 - Allowing the sale of alcohol by 7PM.
 - Increasing traffic flow.

JAPAN COVID-19 NEWS

HIGHLIGHT

- The total number of people vaccinated for the first dose nationwide reached more than 30.24 million, 24% of the total population (127.12 million).
- The number of people who have been vaccinated up to the second dose has reached about 16 million, which is 12.58% in total.
- The vaccination ratio of the elderly over 65 years old (36 million people) is 65% for the first dose and 33% for the second dose.
- The government has announced that 27 million doses of workplace vaccinations will be allocated for firms and 6 million doses for universities.
- The government's target of one million times a day was achieved: about one million times on June 9 and 15, about 1.03 million times on June 16, and about 1.02 million times on June 17.
- The government plans to maintain its goal of completing the vaccination of all citizens by October or November.
- The government has secured 100 million doses of Pfizer's product by June, and a total of 70 million doses are expected between July and September.

QUARANTINE RULES UPDATE:

- The Japanese government is not accepting new arrivals from overseas except Japanese nationals and foreigners who are residents of Japan.
- Entry minimum quarantine conditions:

 - 14-day quarantine after entering Japan.
 - A pledge must be signed as an agreement to abide by the quarantine rules.
 - Download 4 Apps (OEL, MySOS, Google Map, COCOA)
- No use of public transportation during quarantine period
- There are four 14-day quarantine rules for incoming travelers including Japanese.
- Arrivals from total 55 countries and regions where variants have been reported are requested to stay for 3 to 10 days at the facilities designated by government.

- COVID-19 vaccines have shown substantial effects.**

It has been confirmed that after a second dose, the COVID-19 vaccine administered to you has an efficacy of roughly 95% in reducing the risk of developing symptoms (the onset of symptoms) such as fever or cough. The vaccine has been confirmed as being highly effective in preventing the onset of symptoms even in the elderly and people with underlying health conditions such as high blood pressure or diabetes.
- COVID-19 vaccines will not only benefit you but also be an important instrument in reducing the burdens on medical institutions.**

Many aspects of COVID-19 remain unknown. By the end of April 2021, roughly 590,000 people in Japan have been diagnosed with COVID-19 infections, of which more than 10,000 people have died. (The percentage dying or needing intensive care is approximately 1.6% [0.3% for people under 60 years of age and 8.5% for people aged 60 or above].)
- The Government recommends that people get vaccinated because the benefits of vaccination are greater than the risk of side reactions.**

Vaccination may result in the body reacting to the vaccine through local reactions that include pain in the area where the shot was administered and systemic reactions such as fever or headaches. These reactions are more frequent after the second dose than the first dose and the older the recipient is, the less frequently they occur. It is best to be vaccinated when your physical condition is essentially fine and to take things easy after receiving the vaccine.
People with a history of severe allergic reactions, including anaphylaxis, will be observed for longer than usual (30 minutes) after the injection is given, and should anaphylaxis occur, necessary treatment will be provided by medical workers.
The Government recommends that people get vaccinated because at present, serious safety concerns have not arisen and the benefits of taking the vaccine outweigh the drawbacks of side reactions.

We will provide the information clearly and precisely.



- The Government will continually confirm the safety of the vaccines and provide safety-related information.**

When granting approval to the COVID-19 vaccine, the Government examined comparative trials (clinical trials) involving tens of thousands of people in total to confirm that serious side reactions did not occur after vaccination. In order to continually confirm vaccine safety even now that approval has been granted, when anaphylaxis or serious symptoms suspected by a doctor to be connected to the vaccination arise, these cases will be reported and experts will assess the situation, in accordance with the law. These reports will include cases such as the worsening of underlying conditions or death after vaccination in which a causal relationship with the vaccination cannot be immediately assessed. In such cases the Government will gather a wider range of information and conduct an assessment.
- The COVID-19 vaccine will be available free of charge.**

The costs of vaccination for all Japanese nationals and all eligible foreign residents, will be covered in full by public funds.
Vaccines will never be administered without the recipient's consent. We urge the public never to coerce vaccinations at the workplace or upon others around them, and never to treat those who have not received the vaccine in a discriminatory manner.


- The entire government is working in an all-out manner to expedite vaccinations.**

The Government will make all-out efforts to provide local governments with enough vaccine doses by the end of June to enable all elderly persons desiring it to receive their second dose, with the end of July in mind. We will also begin broadly inoculating the general public, including people with underlying health conditions, starting from those municipalities that have prospects for finishing vaccinations of the elderly.



VACCINATION CERTIFICATE

- The government plans to begin paper-based application and issuance of vaccination certificates by mid-July.
- In principle, the vaccination is administered at the municipality where the resident is registered in Japan.
- Vaccination certificates are issued by municipalities that keep records of individual vaccinations.
- Vaccination certificates are issued based on applications from vaccine recipients, including records of vaccinations conducted in municipalities based on the Immunization Law.
- The vaccination certificate will be presented to foreign countries when requested and is a paper based.

- The municipality receives the application form at the counter or by mail, examines and inputs the information using the Vaccination Record System (VRS), and then issues.
- Vaccination Record System (VRS) is a system for recording the vaccination status of individuals.






KOREA COVID-19 NEWS

HIGHLIGHTS

- South Korea's daily new virus cases stayed in the 700s for six consecutive days from June 30, while authorities tighten their guard against a virus resurgence in the greater Seoul area.
- New cases in the greater Seoul area, home to half of the nation's 51 million population, have accounted for over 80% of the total over the past week, and nearly half of them were in their 20s and 30s.

Seoul capital region postpones new relaxed distancing measures as nationwide COVID-19 soars

- In response to the uptick in cases, local governments are postponing the introduction of the new social distancing measures by one week in the entire Seoul capital region, including Incheon and Gyeonggi-do Province.
- The capital region had originally planned to allow gatherings up to 6 people from July 1st, and officially start enforcing level two from July 15th.



HIGHLIGHTS



Vaccinated overseas arrivals exempt from two-week quarantine

- People who have been vaccinated overseas against COVID-19 will be exempt from the mandatory two-week quarantine upon arrival in South Korea starting July 1.
- The new policy applies to Korean nationals and foreigners alike if they are entering Korea to do important business or serve the public interest, for academic or humanitarian purposes, or to visit immediate family.

- Incheon International Airport will implement 'Trip Booster' marketing promotion for the recovery of aviation demand as the government decided to ease immigration restrictions on vaccinated people.
- 'Trip Booster' is a program that selects a team of airlines and travel agencies operating "safety travel products" that are safe from COVID-19 and supports up to \$50,000.



KOREA-Saipan TRAVEL BUBBLE

- Saipan became South Korea's first 'travel bubble' destination, allowing quarantine-free package tours for those who are fully vaccinated with Pfizer, Moderna, AstraZeneca or Janssen.
- Travelers will be required to submit proof of a negative COVID-19 test within 72 hours of departure and a vaccination certificate issued by the country's health authorities.

KOREAN AIRLINES TO RESUME GUAM ROUTE EARLIER THAN EXPECTED

TAIWAN



CECC REITERATES NEED FOR STRICT DISEASE CONTROLS IN MARKETS

- (CNA) Central Epidemic Command Center (CECC) head Chen Shih-chung on Sunday once again reiterated the importance of following COVID-19 control measures currently in place at local markets, in the wake of a recent increase in foot traffic increasing the risk of disease transmission.
- To ensure social distancing and that visitors remain at least 1.5 meters apart, markets are supposed to control visitor numbers, with one person every 2.25 square meters, Chen said.
- Under the current Level 3 alert, he stressed, no on-site dining or food sampling is allowed in markets.
- Such venues are also required to reduce the number of entry points and keep contact information for all visitors, Chen said.



TAIPEI OFFICIALS REASSIGNED AMID COVID VACCINE SCANDAL INVESTIGATION

- Three Taipei City health officials have been reassigned over a scandal involving clinics administering COVID-19 vaccines to people not eligible to receive them, the city government confirmed on Saturday.
- The three officials have been under review since June 19, when an initial internal affairs investigation determined they potentially played a role in the distribution of the vaccine in ways that violated the government protocols.
- One of the clinics, Good Liver Clinic, vaccinated people who work at its two locations and volunteers, even though they did not meet the criteria of being medical workers eligible for the vaccine in early June.
- The clinics have been fined up to NT\$2 million (US\$71,554) per location for the violation and removed from the vaccination program.

PUBLIC COMPLIANCE KEY FOR 'PARTIAL REOPENING' AFTER JULY 12: CECC

- Taiwan's Central Epidemic Command Center (CECC) said Saturday that a partial easing of COVID-19 restrictions after July 12 will depend not only on the status of the outbreak, but also on public alertness and responsiveness to public health protocols.
- Taiwan is currently under a Level 3 COVID-19 alert, which extends at least through July 12. However, there has recently been talk of allowing a "partial reopening," possibly including dine-in services at restaurants, even if the alert is extended.
- At the press conference, Chen also expressed confidence about the current path of the outbreak, saying that "aside from a cluster of infections at wholesale markets in Taipei, case numbers are down, and things are moving in the right direction."

HUNDREDS OF TAIWANESE BOOKING VACCINE TOURISM TRIPS TO GUAM: AGENCY

- A major travel agency in Taiwan said Wednesday that it has been selling hundreds of tours to Guam, as people are taking advantage of the American territory's offer to vaccinate tourists against COVID-19.



- Shortly after the program was announced, there was a flurry of interest among travelers in Taiwan, but that has fallen off somewhat since the Taiwan government last week prohibited home quarantine for returning travelers and mandated that they stay in government centers or designated hotels for the 14-day period, according to Yu.
- Due to that regulation, some Lion Travel customers have canceled their bookings for travel to Guam because they do not want to pay the quarantine costs upon return to Taiwan, he said.
- That has been mitigated to some extent, however, as the Guam government decided Wednesday to exempt visitors from quarantine, effective July 4, once they can present a valid negative COVID-19 test result, Yu said.

- Travelers are required to make an affidavit stating that the location of their intended 14-day home quarantine in Taiwan (to be conducted in a quarantine hotel or in a home with one person per residence) meets relevant regulations.
- Travelers who have traveled to the United Kingdom, the Republic of South Africa, the Kingdom of Eswatini, the Federative Republic of Brazil in the past 14 days (transited in those countries included) would be required to stay at group quarantine facilities after arrival in Taiwan and to receive COVID-19 testing.
- Personnel on diplomatic/official business, migrant workers, [students](#), [international patients\(including companions\)](#) should follow instructions by Ministry of Foreign Affairs, Ministry of Labor, Ministry of Education, and Ministry of Health and Welfare.
- Business travelers who meet requirements announced by the Centers for Disease Control (CDC) may apply for shorten their required quarantine period—See [Regulations concerning short-term business travelers' applications for shortened quarantine periods in Taiwan](#) on CDC website for details.

- Starting June 27, travelers arriving in Taiwan from countries other than the seven countries at high risk of COVID-19 variants (Brazil, India, the UK, Peru, Israel, Indonesia, and Bangladesh), including those who have visited the countries in the past 14 days and those who have transited in the countries, will be allowed to stay in group quarantine facilities at their own expense
- The latest list of the risk categories for countries/regions is as follows:
 - 1. Low-risk countries/regions: New Zealand, Macao, Palau, Fiji, Brunei, Laos, Nauru, East Timor, Mauritius, Vietnam, the Marshall Islands, Cambodia.
 - 2. Medium-risk countries/regions: Australia, Singapore.

TRAVEL ENTRY TO THE PHILIPPINES

ELIGIBLE TRAVELERS TO THE PHILIPPINES

At present, the categories of travelers allowed entry are as follows:

- Filipino nationals
- Non-Filipino/Foreign spouse and minor children or children with special needs of a Filipino national
- Non-Filipino/Foreign parent of a minor Filipino child (18 years old and below) or a child with special needs (regardless of age)
- Former Filipinos (Balikbayan Program), Dual Citizens
- Spouse/Children of Former Filipino Nationals (Balikbayan Program)
- Accredited foreign government and international organization officials and their dependents
- Non-Filipino/Foreign seafarers with 9(c) visa
- Non-Filipino/Foreign nationals in possession of valid certificates
- Non-Filipino/Foreign nationals with an eligible visa



TESTING AND QUARANTINE REQUIREMENTS

Eligible arrivals to the Philippines must take a COVID-19 RT-PCR test upon arrival followed by a 14-day quarantine. Arrivals will be tested on the seventh (7th) day of their 14-day quarantine stay, 10 of which shall be observed at an accredited quarantine hotel/facility, and the remaining days for home quarantine under the supervision of the Local Government Unit of their residence. Day one (1) starts on the day of the passenger's arrival.

Please note that children and infants are not exempt from the quarantine and testing requirements. For minimized discomfort, infants will be swabbed through the mouth.

Travelers are subject to the maximum number of allowed inbound passengers at the port and date of entry.

ALLOWANCES FOR VACCINATED ARRIVALS

- Fully vaccinated arrivals to the Philippines are now exempt from the RT-PCR test requirements and will only undergo a 7-day quarantine at an accredited quarantine hotel or facility. To be considered fully vaccinated, at least 14 days have elapsed following the administering of the second dose or at least 14 days after having received a single-dose vaccine.
- Please note that this is only applicable for travelers who have been fully vaccinated in the Philippines by accredited local vaccine administrators and Local Government Units.
- Filipino Nationals and non-Filipinos who received their vaccination outside the Philippines are NOT eligible for the exemption and reduced mandatory quarantine.

“GREEN” COUNTRIES LIST

The Philippine Government recently established a list of “green” countries allowing fully vaccinated passengers arriving from any country/jurisdiction on the list to quarantine for a shortened period of 7 days. To be eligible to be on the list, the Department of Health must classify the country as “Low Risk” based on disease incidence rate as follows: (1) for populations greater than 100,000, the incidence rate (cumulative new cases over the past 28 days per 100,000 population) and new case trajectory (case trend for daily new cases over the past 28 days); and (2) for populations less than 100,000, the COVID-19 case counts (cumulative new cases over the past 28 days) and new case trajectory are considered, as prescribed by its Technical Advisory Group.

The following countries/jurisdictions are classified as “green” countries:



1 MILLION JAPAN-DONATED COVID-19 VACCINES ARRIVE IN PHILIPPINES

On July 8, the Philippines received a delivery of 1 million doses of Oxford-Astra-Zeneca vaccines donated by Tokyo, Japan. President Rodrigo Duterte said the donation would "go a long way" in helping the country reach its immunization targets. The delivery raises the total supply that the Philippines has received to about 18.4 million. Delays in the delivery of other vaccines recently halted or limited inoculation efforts in several areas.

The Philippines is set to receive another 2 million AstraZeneca doses from vaccine-sharing COVAX Facility this week, and about 170,000 government-procured doses from Russia's Gamaleya Institute.



The government aims to inoculate 58 to 70 million of the Philippines' 109 million people to safely reopen the economy, which suffered its worst postwar slump last year as lockdowns meant to contain the coronavirus outbreak left businesses struggling.

PHILIPPINES EXTENDS COVID-19 CURBS UNTIL MID-JULY

President Rodrigo Duterte has prolonged restrictions on movement and businesses in the Philippine capital and nearby provinces until mid-July, and retained stricter COVID-19 curbs in central and southern areas.

Infections in the capital region, home to at least 13 million people, have dropped since peaking in April, but some provinces are battling spikes as the country scrambles to distribute and administer vaccines.

Entertainment venues, amusement parks, and contact sports are prohibited in the capital region and nearby provinces, while restaurants, gyms and indoor tourist attractions are allowed to operate at up to 40% capacity.
